I, the undersigned have the honour to report that in view of the current prevailing law and order situation and the upcoming Assembly Session, February, 2025 as well as to detect any kind of illegal and to sanifize the any kind of illegal and snatched weapons, incriminating articles concealed and to sanitize the fringe areas proportion of Ksh. fringe areas properly, today i.e. 07/02/2025 at around 6:45 am, under the supervision of Ksh. Seilesh Singh CDO/BPR, teams of Nambol PS led by Inspt. A. Nabakanta Sharma, OC/NBL-PS, SI. L. Bishworaman Singh & HC. N. Gopen Singh, a team of 33-AR led by Devarshi and 8 Bn. CRPF led by AC Rajivkumar in presence of the Executive Magistrate Shri Akoijam Punshiba Meetei, SDC, Oinam. During the search operation, 1 (one) no. of plastic sack was found kept concealed inside the bushes near the foothill in between Irengbam and Aigejang Villages.
