Today i.e. 03/03/2025 at 8:10 pm received a reliable information that on the same day at about 8:00 one Auto Rickshaw have pm one Auto Rickshaw bearing regd. No. MN04D-6410, driven by one unknown driver which was proceeding from Nowholeside. proceeding from Nambol side towards Imphal side suddenly skid on the road towards a Tata Truck bearing read. No. MNOST 4691 direction. regd. No. MN03T-4681 driven by an unknown driver which was proceeding from the opposite direction, while trying to avoid dark. while trying to avoid dashing the said Auto Rickshaw and it dashed to one Honda Activa bearing regd. No. Nil which was also plying from Nambol side towards Imphal at Phoijing bridge along Tiddim road due to rash and negligent driving on the part of the unknown drivers of Auto Rickshaw, Tata Truck and unknown rider of Honda Astronomy rider of Honda Activa. As a result of which the unknown rider and pillion rider of Honda Activa sustained injuries on their rider. injuries on their persons and evacuated to hospital for medical treatment. And all the three vehicles were also partly damaged.
