Today i.e. on 9th April 2025, at approximately 7:30 AM, information was received regarding an incident that occurred earlier the same day at around 1:40 AM. Two unidentified assailants, riding a two-wheeler, opened fire at the "Children Home for Boys" located at Sagolband Meino Leirak, Imphal West District, Manipur. Fortunately, there were no casualties. However, the incident caused panic among the residents and disturbed the peace of the surrounding locality. The act appears to have been carried out with an intent to endanger human life and create public alarm.

Hence, a suo-motu case under FIR NO. 100(4)2025 IPS U/S U/S 109/324(4)/351(3)/3(5) BNS & 25(1-B) Arms Act. has been registered against the unknown miscreants for investigation.
