Sir,

I have the honour to report that on 4-12-2023, Meera Devi, W/o Bishwakanta Potshangbam Keishamthong Nganappithong Mapal had brought Jamuna Devi and Abenao Devi you and your daughter namely Lukram Abenao Devi to my house. Meera Devi had introduced Jamuna Devi as a pensioner and Abenao Devi is the daughter of Jamuna Devi was shown one Pension Book under PPO No. 800070248760 and Jamuna Devi and Meera Devi requested me for giving a sum of Rs. 600, 000/- to Jamuna Devi for urgent need of her family by handing over the said pension book (original), Bank Passbook in the name of Jamuna Devi being A/C/ No. 8761000100037979 of Punjab National Bank of Lamphel RIMS Branch Office. She (Jamuna) assured me that the said amount would be repaid with an interest at the rate of 2.5 % per month and that the principal amount would also be returned to me within the month of January, 2025 without fail. Believing the promise and assurance of Jamuna Devi and Meera Devi who is also known by me and resident of my locality, I had given a sum of Rs. 6, 00, 000/- (Rupees six lakhs) to Jamuna Devi at my residence in presence of her (Jamuna) daughter Lukram Abenao Devi, Potshangbam Meera Devi and my wife namely Laishram (0) Bijaya Devi by executing a money receipt and a promissory Note. They also handed over copies of the Aadhaar Cards of Jamuna Devi and her daughter, in addition to the above documents again, on 1-5-2024 Jamuna Devi came to my residence and requested me to give another amount of Rs. 1, 00, 000/- (Rupees one lakh) in addition to Rs. 6, 00, 0000/- and she assured that total amount of Rs. 7, 00, 000/- would be returned to me without fail on the day. Month and year made earlier. I had received interest up to the month of July 2024. Then Jamuna Devi and Meera Devi have not responded properly and neglected my request for returning my money and outstanding due interest. In the beginning of February, 2025, I had visited the residence of a retired SSB personnel, at Heirangoithong West, Imphal. On my request my friend had confirmed from other SSB staffs now serving at outside the state regarding the correctness of the pension book in the name of Jamuna Devi. I came to know that the said Pension book seems to be a fake one and there is no any employee/pensioner found matching with the PPO No. 800070248760. On 21-3-2025 I sent a legal notice to all the above mentioned three persons through my lawyer demanding the return of my principal amount and due interest. But no response from the side of the said three persons has so far been received either by me or my lawyer till date.

I, therefore, requested the Respected Sir to kindly take necessary legal action against the above mentioned three persons for the act of cheating, deceiving, forgery for cheating and criminal conspiracy and criminal breach of trust in order to induce me for the delivery my money.
