**12. First Information contents:**

Today i.e. 25<sup>th</sup> April., 2025 at 02:10 PM, a disturbing and provocative video was circulated in different platforms of social media with the caption "Ngashi Hayingkhongban gi IBUDOU PAKHANGBA gi khubam thugaini na lakhiba pangal machashing amashung SDO busu yade haibadu khanghankhre". The post was uploaded by one Face book user namely "Chinglai Pari I". The voice of the viral video is reproduced as follows, "Noi Khitnag Khallu Yadro Noibo Noi Yum Yumda Laigaa amfao khurumdrabo Noibo Noi Noi Nacha Nasu Laigaa Amata Khoirumdra Jatlo, Si Khillise Ubada Kaim Khandrabo Noibo."

The caption of the viral post is translates as follows, "Today those Muslims and SDO who came to vandalize the sacred site of Hayingkhongban Ibudou Pakhangba were taught a lesson."

The voice of the viral video is also translates as follows, "Why don't you think at all? Don't you ever prayed to God at home? Don't your children ever prayed to God? Don't you notice what is there or do you not even know what it is?"

The viral video with the provocative caption posted by the Face book user "Chinglai Pari I" is very disturbing, alarming and communal. The viral post causes fear and alarm to the general public, or to induce any person to commit any offence against the public tranquillity and incites any class of community promoting enmity, hatred or ill-will between classes on the ground of religion caste or community at this juncture of crisis in Manipur.

Hence, a suo-mottu case under FIR No. 127(04)2025 IPS 196(1)(a)(b)/353(1)(b)(c)(2)/61(2) BNS has been registered against the face book user "Chinglai Pari I" for investigation.
