Today i.e. 03/05/2025 at 8.30 pm, received a reliable information that one Sanathoi Meitei, S/S Finance In-Charge (Central Committee) of the outfit *Manipur Liberation United Front (MLUF)* served a demand letter vide Ref No. 302/FIC-23/MLUF-2025 dated 01/05/2025 for an amount of **Rs. 5 lakhs** from the authority of Suba Hospital & Assisted Reproductive Centre, Kombirei Keithel, Imphal West, Manipur.

The said demand has caused intimidation, fear and harassment to the hospital and its management staffs. Such unlawful activity has affected/disrupted the normal functioning and safety of a public serving medical institution.

Hence, a suo-motu case under FIR No. 142(05)2025 IPS u/s 308(2)(4)/313/351(2)/3(5) BNS has been registered against Sanathoi Meitei, Finance In-Charge (Central Committee) of the outfit *Manipur Liberation United Front (MLUF)* for investigation.
