I have the honour to state that today i.e., 09/05/2025 at around 11.30 am, three unknown armed miscreants wearing mask who came on one Hyundai Creta, White in colour, entered inside my Mobile shop "Mr. Mobi" located at 1st Floor of Larho Arcade, Chingmeirong Dinku Road, Imphal East District, Manipur. The armed miscreants forcefully looted around 18 mobile handsets and 2 smart watches valued about Rs. 5,50,000/- approximately at gunpoint by instant threat to kill me at the spot. They fled away from the scene very swiftly after commission of the crime. The particulars of some of the looted phones are given below:
