Subject: - Report.



Sir,

I have the honour to state that today i.e. 09/05/2025 at about 11:30 am, a reliable information was received regarding the presence of some active cadres of UNLF organization in and around Uripok area with a view to commit prejudicial activities like extortion of money from the general public and shops etc. Based on the information, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri P. Achouba Meetei, MPS, DSP(CDO)/IW, under the supervision of Shri Gaurav Dogra, IPS, i/c Addl. SP(Ops.)/IW and overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Uripok Khoisnam Leikai area. During that two suspected persons were detained for spot verification and checking at Uripok Khoisnam Leikai near Central Dental Clinic, Imphal West District. During spot verification, they identified themselves as (i) Kshetrimayum Blish (20 yrs) @ Lamyanba S/o. Ksh. Dhanachandra Singh of Kwakeithel Akham Leikai, Imphal West District and (ii) Pebam Jet Singh (26 yrs) S/o. P. Jiten Singh of Napet Palli Maning Leikai, Imphal East District.

During preliminary verification, Kshetrimayum Blish disclosed that he is an active cadre of UNLF (P) organization (a faction of UNLF organization) and joined the said organization in June, 2023 through one Roshan @ Phajaba of UNLF (P) organization from Sagoltongba area and got Basic Military Training for 2 months at Ingourok/Nongpok Sekmai area in the year 2024 and he was allotted MPA No. 3312.

And, Pebam Jet Singh disclosed that he is an active member of UNLF (P) organization (a faction of UNLF organization) and joined the said organization in February, 2025.

Both of them further disclosed that they are presently working under the command of one s/s Commander Wangol, Chief RO of UNLF (P) organization and under the instruction of their s/s Commander Wangol, they were involved in extortion activities by serving monetary demands/threats and collecting money from different schools, government departments/officials and general public located in valley area and the extorted money of around Rs. 15 lakhs were earlier handed over to their Commander Wangol as their party fund. They also disclosed that they used one Hyundai i10 car red in colour bearing registration no. AS01DU 6224 to carry out their party activities and the said car was driven by Kshetrimayum Blish. As pointed out by Kshetrimayum Blish, the said Hyundai i10 car red in colour bearing registration no. AS01DU 6224 was found parked near the spot.

Hence, Kshetrimayum Blish and Pebam Jet Singh were arrested from the spot i.e., Uripok Khoisnam Leikai near Central Dental Clinic, Imphal West District at 12:35 pm and 12:46 pm respectively by observing necessary formalities.

From the possession/at the instance of Kshetrimayum Blish, (i) one Samsung Galaxy A15 5G mobile handset along with one Airtel SIM card bearing mobile no. 9383226402 (as disclosed by him) and (ii) one wallet black in colour containing a sum of Rs. 250/- (two hundred and fifty only) and one Aadhaar card bearing no. 6565 1747 0544 and (iii) one Hyundai i10 car red in colour bearing registration no. AS01DU 6224 along with its key were seized from the spot at 12:42 pm by observing due formalities.

From the possession of Pebam Jet Singh, (i) one VIVO Y100 mobile handset along with one Airtel SIM card bearing mobile no. 9233836897 (as disclosed by him), (ii) one Redmi Note 13 5G mobile handset along with one Airtel SIM card bearing mobile no. 7640923145 (as disclosed by him), (iii) one VIVO Y300 5G mobile handset along with one Airtel SIM card bearing mobile no. 7085540669 (as disclosed by him), (iv) one realme mobile handset model no. RMX3430 along with one Airtel SIM card bearing mobile no. 8132087208 (as disclosed by him) were seized from the spot at 12:56 pm by observing due formalities.

Hence, the arrested persons and the seized articles are handed over to you for taking further necessary legal action against them.


