I am to bring to your notice that on 4th May, 2023 at around 3:30 am my residential house located at Thumkhonglok, PS- Loktak, District-Churachandpur, Manipur was attacked, vandalized, looted and burned by a group of Meetei (Arambai Tenggol/ Meetei Leepun).

These criminals broke and open my gate, vandalized, looted every valuable properties from my residential house and premises worth Rs. 7, 86,400/- (Approx) and they burned down all the remaining things and the residential house.

Cause of delay- Due to displacement from the relief camp to another and lack of knowledge and understanding.

It is therefore request to kindly take up the necessary legal action against the criminal involved in the commission of the crime at the earliest.
