Subject: A complaint against the unknown individuals which was/were seen in the "X" posted by "Lomlhangsom Express" @ByteHou61387 on 28-04-2025.

Sir,

Today, I found a video footage which was posted by "Lomlhangsom Express" @ByteHou61387 on "X" under the caption "1930s, our forefathers performed cultural activities and rituals atop Thangting Hill. After embracing Christianity, we distanced ourselves from these practices, deeming them incompatible with Christian life. Today, April 26, 2025, we performed cultural dances that reflect our Christian". This post clearly shows that on April 26<sup>th</sup> 2025, the Kuki community was permitted to perform dances a top Thangjing Hill of Meitei's Sacred site (they alleged it as Thangting), reflecting/embracing of their Christian identity. However, the Meitei community denied access by security forces to conduct our centuries-old ritual, Thangjing Ching Kaba and Ibudhou Thangjing Khurumba, at the same sacred site, despite its deep cultural and religious significance. This selective restriction violates our constitutional right to religious freedom and creates and unfired disparity between communities.

Therefore, you are requested kindly to take appropriate action against all responsible persons including security forces, if any, to safeguard our cultural heritage and to protect equality before long and equal protection of law.

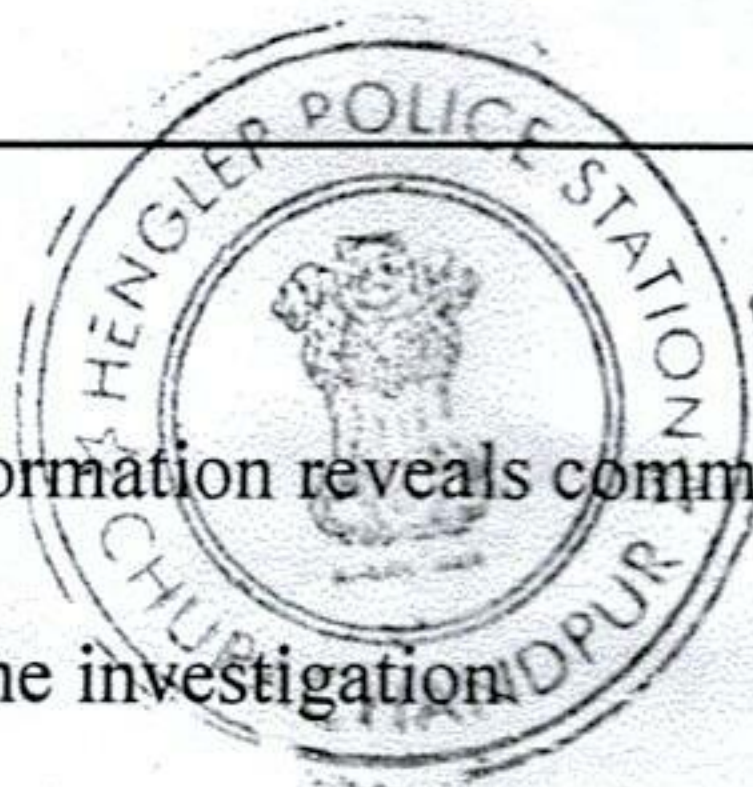

This post clearly shows that on April 24, 2025, the  
Kuki community was permitted to perform cultural dance  
atop Thangjing Hill of Meitei's Sacred Site (they allege  
it as Thangjing), <sup>embracing &</sup> reflecting their Christian identity.

However, the Meitei community was denied access  
by security forces to conduct our centuries-old  
ritual, Thangjing Khing Kabu and Thangjing Thangjing  
Khumbaba, at the same sacred site, despite its deep
