Subject: First Information Report

Sir,



- (1) 37 Assam Rifles has been constantly tracking and monitoring the drug trade in Churachdpur & cross Indo – Myanmar border movement of drugs. As a result numerous successful operations have been carried out by the unit over the last few weeks. On 05 May 2025, the unit seized 108 soap cases containing approx. 1.296kgs of suspected Heroin No. 4 (worth approx. 12.3 crores), on 06 May 2025 the unit seized 24 soap cases of suspected No. 4 Heroin weighing approx 288gms worth approx. 2.73 crores and WIY tablets – qty 01 lakh weighing approx 11.580 kgs worth approx Rs. 9.26 crores, on 10 May the unit seized 97 soap cases of suspected No. 4 Heroin weighing approx 1.164kgs worth approx Rs 11.05 crores and on 22 May the unit seized 870gms Brown sugar worth approx Rs. 1.74 crores (Rs 8.5 crores approx in international market) & 20 x soap cases of suspected No. 4 Heroin weighing 260gms worth approx Rs. 52 lakh (Rs. 1.5 crores approx in international market) alongwith Rs. 29.5 lakhs Indian currency (acquired by individual from drug deals). This dealt a severe blow to the drug trafficking nexus of the area. As a result, the drug smugglers attempted to produce more drugs for selling in Churachandpur & further to mainland India.
- (2) On 24 May 2025 at approx 1740hrs, based on the tip off from technical sources & ground sources, the COB Suangdai, IMB crossing point team apprehended the following individuals and vehicles with Rs. 1,17,30,600 (rupees one crore seventeen lakh thirty thousand six hundred).
- (3) Details of the apprehendees:
  - (a) Nangkhanthiau (47 yrs) residednt of Sehjang Village, CCPur – Dist, Manipur
  - (b) Tuangpu Guite (41 yrs) resident of Gangpimual Village, CCPur – Dist, Manipur
- (4) Details of rec.
  - (a) Rs. 1,17,30,600 (rupees one crore seventeen lakh thirty thousand six hundred).
- (5) On investigation, it was revealed that these persons were carrying the INR across to Haicin to be handed to an individual named Henry, allegedly to buy more drugs for subsequent sale in Churachandpur



- (6) The accused indls alongwith recoveries are hereby handed over to Singngat police at 1400 hrs on 25 May 2025 for further necessary action. You are requested to lodge an FIR and take up legal action as per law of the land.
- (7) Copy of apprehension & seizure memo have been furnished to the accused at 0900 hrs on 25 May 2025. Also, the next of kin of the accused was promptly informed right after the apprehension.
- (8) It is also requested no to release the confiscated amount to the accused or any party under any circumstances.
