

Sir,

With due regards, I beg to state that today on 19/02/2025 at about 3.30 p.m received an input from 7th MR that some unknown armed miscreants have stored and hidden some arms, ammunitions and explosives at the foothill of Irong village for using offensive act against State Security Forces and CAPF.

On receipt of the information, Special Operation Group (SOG) Thoubal District Police along with a column of 165 TA led by Shri H. Devendra Singh, Addl. SP(Ops)/TBL assisted by Shri Y. Sunanta Singh, MPS Dy.SP(H/Q), Thoubal and under the overall supervision of Shri Dr. S. Ibomcha Singh, MPS Superintendent of Police Thoubal District have rushed to the spot immediately and launched a massive operation at 5:00 p.m. by using metal detectors. On searching and found the undernoted articles i.e. (1) 1(one) no. of SLR Rifle bearing registration No. 18060318 OFT-IN-2007 with magazine, (2) 1(one) no. of 5.56 Rifle, (3) 4(four) nos. of 36 HE hand grenade, (4) 1(one) no. of Chinese Hand Grenade, (5) 5 (five) nos. of 7.62mm live round, (6) 2(two) nos. of 5.56mm magazine, (7) 1(one) no. of Tear Smoke Shell L/R, (8) 1(one) no. of Tear Smoke Shell Soft noise, (9) 2(two) nos. of Green Smoke 80MK1, (10) 2(two) nos. of Baofeng Radio set along with Antenna, (11) 1(one) no. of charger from the spot at 6:20 pm. The massive searched Operation was conducted from 05.00 pm to 6:30 pm on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
