12. First Information contents:

On 14th May 2025, at around 2035 hours, Base on incredible intelligence inputs, corroborated during interrogation of SS Sgt Major David (apprehended on 13th May 2025), it was revealed that insurgent elements were likely to move with weapons from Sajik Tampak towards Churachandpur. Accordingly, a column under the command of NB/Sub Dambar Kumar Rai and a team of Sangaikot Police Under the overall Supervision of Shri L. Lhunminlal Khongsai MPS, OC/SKT-PS launched an MVCP, Sangaikot at 2000 Hrs on 14th May 2025.

Approximately at 2035 Hrs a Grey Bolero Vehicle without number plate approached the MVCP, Sangaikot and attempt to escape at high speed, the quick response and the effective road block using an armored vehicle led to successful interception. On searching the vehicle following items were recovered:-

1. Automatic Rifle (MA-3) Factory Made (Non service) with 02 Mag-01
2. 5.56 Ammns-05 Rds
3. Mobile Phone alongwith SIM Card-01
4. Bolero Grey Colour without No. Plate-01

Sub : TO LODGE AN FIR AGAINST MR. HAOVANGLIAN AND MR. LOVESON MANGCHINLIAN

Sir,

1. 36 Assam Rifles had been tracking the movement & activities of the apprehended individuals namely:-
  - (a) Mr. Haovanglian (Age 28), S/o (L) Thangkhanmang, R/o Sajik Tampak Chandel
  - (b) Mr. Loveson Mangchinlian (Age 23), S/o Thangsuonpao, R/o Sajik Tampak Chandel
2. Based on credible intelligence inputs, corroborated during interrogation of self-styled Sgt Major David (apprehended on 13 May 2025), it was revealed that insurgent element were likely to move with weapons from Sajik Tampak towards Churachandpur. Accordingly, column (strength 01-01-15) under the command of N6/Sub Dambay Kumar Raiwa launched from COB Sangaikot at 2000 hrs on 13 May 2025. A Mobile Vehicle Check Post (MVCP) was established near Sangaikot Police Station.
3. At approximately 2035 hrs, a grey Bolero vehicle without number plate approached the MVCP and attempted to escape at high speed. The quick response and effective road block using an armoured vehicle led to successful interception. On searching the vehicle, the following items were recovered:
4. During the search, the following items were recovered from their possession:
  - (a) 01 x Automatic Rifle (MA-3) with 02 x Mag
  - (b) 05 x 5.56 Amn rds
  - (c) One mobile phone alongwith One SIM Cards with IMEI - 1. 35568527389118 & IMEI - 2. 355685274019271.
  - (d) 01 x Bolero Grey colour without Number plate
5. The apprehended individuals have been identified as:-
  - (a) Mr. Haovanglian (28), S/o (L) Thangkhanmang, R/o Sajik Tampak, Chandel
  - (b) Mr. Loveson Mangchinlian (23), S/o Mr. Thangsuonpao, R/o Sajik Tampak Chandel
6. Both individuals are suspected to be active members of the CKLA outfit and have been involved in transporting illegal arms and war-like stores.
7. It is requested that an FIR be registered under relevant sections of IPC, Arms Act, and UA(P)A for further investigation and legal action.
