12. First Information contents:

On 14th May 2025, at around 2035 hours, Base on incredible intelligence inputs, corroborated during interrogation of SS Sgt Major David (apprehended on 13th May 2025), it was revealed that insurgent elements were likely to move with weapons from Sajik Tampak towards Churachandpur. Accordingly, a column under the command of NB/Sub Dambar Kumar Rai and a team of Sangaikot Police Under the overall Supervision of Shri L. Lhunminlal Khongsai MPS, OC/SKT-PS launched an MVCP, Sangaikot at 2000 Hrs on 14th May 2025.

Approximately at 2035 Hrs a Grey Bolero Vehicle without number plate approached the MVCP, Sangaikot and attempt to escape at high speed, the quick response and the effective road block using an armored vehicle led to successful interception. On searching the vehicle following items were recovered:-

- 1. Automatic Rifle (MA-3) Factory Made (Non service) with 02 Mag-01
- 2. 5.56 Ammns-05 Rds
- 3. Mobile Phone alongwith SIM Card-01
- 4. Bolero Grey Colour without No. Plate-01

Sir,

- 36 Assam Rifles had been tracking the movement & activities of the apprehended individuals namely:-
 - Mr. Haovanglian (Age 28), S/o (L) Thangkhanmang, R/o Sajik Tampak (a) Chandel
 - Mr. Loveson Mangchinlian (Age 23), S/o Thangsuonpao, R/o Sajik Tampak Chandel
- Based on credible intelligence inputs, corroborated during interrogation of self-styles Sgt Major David (apprehended on 13 May 2025), it was revealed that insurgent element were likely to move with weapons from Sajik Tampak towards Churachandpur. Accordingly, column (strength 01-01-15) under the command of N6/Sub Dambar Kumay Raiwa launched from COB Sangaikot at 2000 hrs on 13 May 2025. A Mobile Vehicle Check Pos (MVCP) was established near Sangaikot Police Station.
- At approximately 2035 hrs, a grey Bolero vehicle without number plate approached th MVCP and attempted to escape at high speed. The quick response and effective road bloc using an armoured vehicle led to successful interception. On searching the vehicle, the following items were recovered:
- During the search, the following items were recovered from their possession: 4.
 - 01 x Automatic Rifle (MA-3) with 02 x Mag (a)
 - 05 x 5.56 Amn rds (b)
