

Sir,

I am to report that today i.e. 20/03/2025 at 07:10 am received a reliable information that some unknown armed miscreants have been hidden some arms, ammunitions and explosive substances at Yairipok Gwarok hill for offensive act against Security forces and CAPF.

On receipt of the information, Police team led by Shri Gaurav Dogra IPS, SDPO/Yairipok, Inspt. N. Suresh Singh, OC/YPK-PS along with personnel of 105 Bn. BSF stationed at Yairipok PS under the supervision of Shri. Shivanand Surve, IPS, SP/TBL rushed to the spot immediately and launched a massive operation at 07:30 am. On searching the area with hand-held metal detectors, the following articles i.e. (1) One 7.62 mm SLR along with empty magazine bearing No. 15286060 (2) One 7.62 mm SLR along with empty magazine bearing No. T0835 (3) 20 nos. of .303 live ammunitions along with four cartridge charger guard were found from the spot at 07:50 am which were wrapped in two gunny bags. Hence the above noted incriminating articles were seized at 07:56 am from the spot by observing formalities. The massive search operation was conducted from 07:30 am to 08:35 am on the same day.

So, I therefore handed over the seized articles to you for your kind taking necessary legal action.
