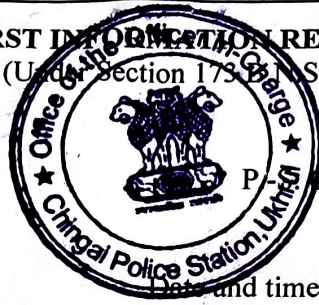

First Information contents: Today i.e; 18/05/2025 at around 12:30 P.m; the complainant namely Pamching Kasomwoshi F/o Ramnganing Kasomwoshi of Namrei village, Ukhrul and 2) Chipemmi Kasomwoshi S/o Peter Kasomwoshi of Namrei village, Ukhrul District, that on 03rd May, 2025 at around 4:30pm, while the complainant/Victim No.1. Chipemmi Kasomwoshi S/o Peter Kasomwoshi was setting outside the residence of Mr. M.

Leishisan, Accused No.2 came and asked/demanded an Alcohol, when it was denied, Accused No.2 verbally and physical assaulted by punching on the face of the victim No.1. That after the said incident Victim No.1 went home. Manipal Police I.T.F - 1

and informed the incident to the family members and relatives. Hence, for settling the matters, Victim No.1. Sochipem Kasomwoshi S/o Pamching Kasomwoshi along with Victim No.2; Mr. Ramnganing Kasomwoshi S/o Pamching Kasomwoshi went to the accused No.2 and tried to settle the matter at Namrei Mission Playground, Namrei village. That the time of discussion/settling the matter/issue, accused No.2 was accompanied by his family members and relatives. During middle of the discussion, Accused No.3 took out his phone and flash the phone light over the Victims eyes, and at that very moment accused No.1 took out his knife and stabbed at Victim No.2 on his abdomen and run away and even the family members and relatives of the accused too run away from that very place. The incident occurred approximately at around 8:pm. The act was deliberate and made with clear intention to cause the Victim No.2 death. That the following witnesses namely, Mr. Ramyo S/o Lt. M. Huimi, Mr. Sochipem Kasomwoshi S/o Pamching Kasomwoshi and Mr. Runmi Kasomwoshi S/o Peter Kasomwoshi witness the above stated facts and who will be prosecution witness. That after the incident the Victim No.2 (Mr. Ramnganing Kasomwoshi) was brought to the District hospital, Ukhrul. But due to the gravity of the injury/seriousness of the injury, The doctor refers the victim No.2 to the JNMS hospital, Imphal. That victim No.2 (Mr. Ramnganing kasomwoshi) is still undergoing medical treatment at JNMS Hospital, Imphal and the condition is critical. For evidentiary proof a photograph of the injury mark and medical treatment at JNMS hospital Imphal is annexed here under. That the delay in filing the present complaint before competent police station is not intentional but circumstantial. That we will cooperate fully with the investigation and provide further details of the facts as required. We have full faith and trust before the competent authority for ensuring justice to the victims. Hence the case.

Based on the GD No.09/CGI-PS/2025 dated 18/05/2025 case under FIR No. 1(05)2025 CGI-PS u/s 109, 118, 115, r/w 46,3(5)- BNS, 2023 is registered for investigation.
