Today i.e 7/5/2025 at 1.32 pm, it has come to the notice of this office that an unidentified individual(s) has created and is operating a WhatsApp accounts bearing Number +8562050955687 and +8562050958810 and impersonating the Director General of Police, Manipur. The impersonator(s) are using the display name and profile picture of the DGP, Manipur to create a deceptive appearance of authenticity.

The impersonator is reportedly reaching out to various government officials and staff via WhatsApp messages on 7/5/2025 starting from 1:25 pm (screenshot enclosed). The fraudulent communication includes soliciting money under false pretences making unofficial requests thereby providing bank account of one Punjab National Bank bearing A/c No. 1041200100008513,IFSC:PUNB0104120, Kohima Branch, accountholder Bimla Khatri Chetri through Whatsapp by the impersonator. Futher, it is highly suspected that the imposter potentially attempting to extract confidential or sensitive information.
