I had opened Saving Bank Account in the then Allahabad Bank now Indian Bank on 21/04/1994 bearing Account No. 2115507071. I did not have any regular income as can be seen in my Account.

On 21/2/2025, I was served a notice by the Income tax Department to explain the huge transaction in my Indian Bank Account From this notice, I came to know that the act of Fraudulence had occurred in my Account.

There was huge transaction in my Account on 05/10/2016, 27/9/2016, 30/09/2016. The Income Tax Department issued notice to me after a lapse of 8 years. To prove the genuineness of the depositor, producing Pan Card is mandatory. The material evidences are with the bank. Since the bank had not furnished the information I sought for the connivance of the Bank Staff with the fraud in the transaction in my account cannot be ruled out.

It is therefore, requested that deemed fit legal action be taken up against the fraud/criminal for the end of Justice.
