With due respect, I have the honour to report that today i.e. 21/05/2025 @ 8:30 am, while conducting random frisking and checking by joint operation team of Mao-PS Police Team along with B/109 and A/109 QAT of CRPF and B-Coy of 16 A.R., QAT., at Mao Gate Police check point about @ 1 km N/West of Mao-PS, one Baleno car (silver colour) bearing Regd. No. AS12AH2897 was seen coming from Imphal side towards Mao along NH-2. The said vehicle was stopped by the joint team for frisking and checking. While checking, 38(thirty eight) soap cases of suspected brown sugar was found concealed inside both the left and right back side indicators. The driver identified himself as Saidul Islam 33yrs S/o Iman Ali of Bharaghat Village, Sonitpur District, P.S. Bharaghat Assam and one occupant identified as Sahidul Islam 21 yrs s/o Rustam Ali of Chamdhara village Sonitpur District, Assam admitted to have possessed suspected Brown sugar inside the vehicle. ADM/MAO was intimated and a request was made for authorizing the detailed inspection of vehicle. Accordingly ADM/MAO Shri. N. Leisan (45) yrs. (Executive Magistrate), Song Song himself arrived for doing the necessary procedures. The vehicle was checked in the presence of Shri. N. Leisan, ADM/Mao, police personnel and B/109 and A/109 QAT of CRPF and B-Coy of 16 A.R., QAT.

The 38 (thirty eight) transparent plastic packet (without the weight of 38 soap cases) were weighed by using weighing machine with video coverage as per BNSS in presence of the Executive Magistrate and witnesses and it was found to be 442 grams. S/o Iman Ali of Bharaghat Village, Sonitpur District, P.S. Bharaghat Assam bearing No. 491864288731 and Sahidul Islam (21) yrs. S/o Rustam Ali of Chamdhara village Sonitpur District, Assam bearing no. 291053619105 were recovered. Hence, the above mentioned articles were seized by preparing a seizure memo at 9:45 am and formally arrested the driver and the occupant at 10.00 am by observing formalities at the spot.
