I have the honour to state that today i.e 27/05/2025 at about 12:00 noon a team of 16th AR led by Maj. Vijay Singh and Maram Police Station conducted frisking and checking at Biisho Bridge 5 Km away from the PS. One suspected Bolero pickup bearing regd.
