1. Credible inputs were being recd over the last 2-3 weeks regarding the tpt of drugs to CCPur via Songdoh – Singhat/ Behiang – Singhat axis, as the harvested poppy in Myanmar is likely to have been processed into Heroin No 4. Multiple MVCPs with variable timings & locs were dply all along the NH-102B, incl Songdoh, Songtal, Singhat, Bualkot, Behiang & Khuga, coupled with regular tracking of suspected mob nos through 11 WEU. It revealed that there has been a change in modus op of the drug peddlers. Wherein, instead of commercial vehs, pnt cars are being used during daytime to avoid easy detection & checking.

2. Based on corroborated inputs of own sources on 03 May at approx 0800hrs, an input was recd about a white car carrying drugs moving towards CCPur through Khuga. Maj Yadu Krishnan imdtly activated his MVCP & moved from Singhat to Khuga, checking all cars matching the description on the way. He simultaneously alerted the PVCP at Khuga, which apprehended a white Hyundai Creta veh at approx 0810hrs. The search of the veh revealed Heroin No.4 drugs weight 5.016 Kgs in 418 Soap cases, worth Rs. 48.7 crores in the intl mkt, being carrying in the car boot.

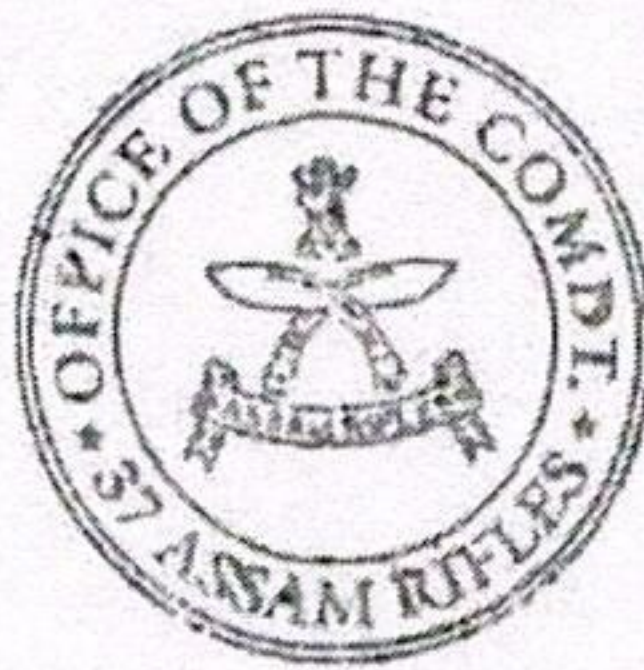
