The said unidentified groups vandalized/burned my house and looted all valuable items. In the unfortunate incident, I have lost our house and property amounting to a total of about Rs. 20,00,000/-.

After the said unfortunate incident /mob violence, my family fled our village in Churachandpur and is taking shelter at relief camp situated at Hostel-2, Khuman Lampak Sports Complex, Imphal East, Manipur.

It is, therefore my prayer that respected Sir may kindly initiate and take necessary legal action(s) against the accused people and the persons involved in the said inhuman acts and heinous crime as per the law of the land as early as possible.

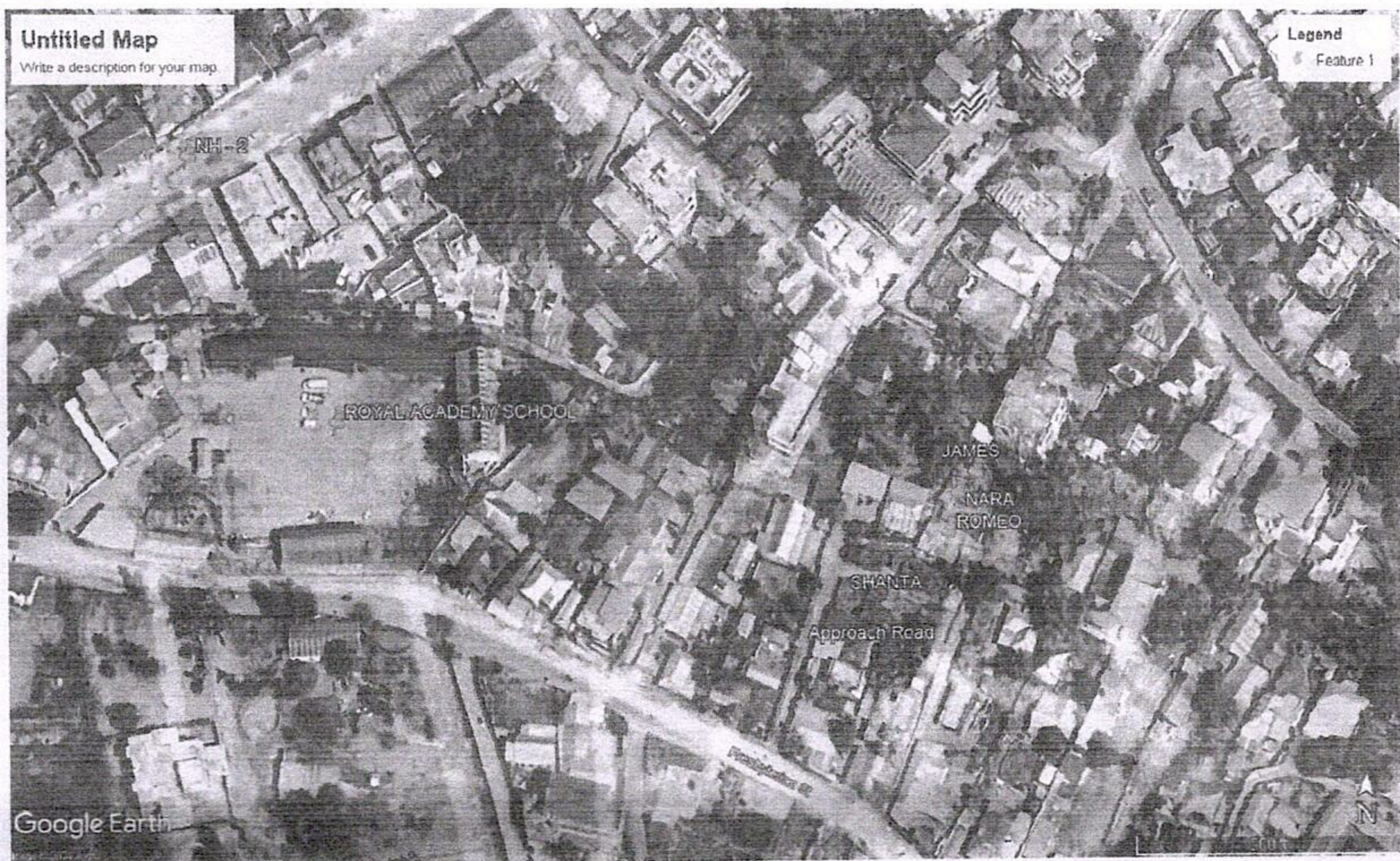
