

## FIRST INFORMATION REPORT

- 1. Reliable inputs had been received over the past few weeks regarding the transportation of drugs from Myanmar to Silchar via Churachandpur,through the Chakpikarong-Singheu axis. Due to extensive patrolling and MVCPs(Mobile Vehicle Check Posts) by 37 Assam Rifles along the Songdoih-Behiang axis, drug trafficking gradually shifted towards the Chakpikarong-Singheu-Churachandpur route. After cultivating various sources and conducting meticulous surveillance through 11 WEU, Maj Yadu Khrishnan PS and Maj Mohit Podia of 37 Assam Rifles established an intelligence grid to track the smuggling network. It was discovered that the perpetrators had adopted a new modus operandi by concealing drugs inside gas cylinders, which had specially made chambers. Since gas cylinders are rarely suspected of being used to hide contraband, this method was particulary effective. The officers identified this tactic and began tracking multiple potential smuggling attempts. They focused on one such smuggler, Mr Kukhup, a resident of Chakpikarong, and posed as buyers to gain his trust.
- 2. After convincing the seller and continously tracking his mobile number, the dealer sent the drugs on 05 May 2025 in a green Bolero bearing registration number MN 04 P 0973, driven by Mr Letminthang (29 years), resident of P Chehjang Village, Chandel-Dist, Manipur. While posing as buyers and obtaining the vehicles location, the team under Maj Mohit Podia and Maj Yadu Krishnan PS intercepted the vehicle and apprehended the driver at 0900 hrs on 05 May 2025 at Gouchinkhup Veng. The search of the vehicle revealed 02 gas cylinders containing 108 soap cases with approx 1.296Kgs of suspected Heroin No 4 (worth approx 12.3 crores) in the international market.
