

Subject: Report.



Sir,

I have the honour to report that today i.e. 13th May, 2025 at about 12:30 PM, I received a reliable information that Mr. David Mungsanglian (33) Yrs s/o. Thangginsuan of Vaal Veng A/P. Lanva Village Churachandpur is selling and running a business of suspected contraband items at one house located at Lanva Village, Churachandpur. Accordingly, requisition was made to District Magistrate to depute one Executive Magistrate for conducting house search. In the meantime, one team of CCP-PS led by self and ASI T. Pauliansiam of CCP-PS immediately moved to the said spot and the Executive Magistrate namely Shri. Satkhogin Kilong also arrived at the spot. On reaching the said house Mr. David Mungsanglian (33) Yrs s/o. Thangginsuan of Vaal Veng, CCP A/P. Lanva Village Churachandpur was found inside the house. Option statement was given in writing to the accused person that, he had the right to choose whether his body or house to be searched before the Gazetted Officer or Executive Magistrate or in presence of any witnesses as I have strongly suspected him to be in possession of Narcotic Drugs and Psychotropic Substances. In that he chooses to be searched in front of any witnesses. As such, body searched was conducted in the presence of Executive Magistrate, however nothing was found on his persons. An house search was conducted at the residence of Mr. David Mungsanglian in the presence of Executive Magistrate by observing necessary formalities. During the search 112 (one hundred and twelve) Soap cases of suspected Brown Sugar wrapped inside plastic packets were recovered which was kept concealed at his bedroom. The suspected brown sugar was open from the soap cases and weighed by using weighing scale and marked as A1 to A112 on each soap cases. On weighing the suspected Brown Sugar the following weight was found for each of the soap cases. (a) Soap cases marked as A3, A5, A12, A13, A15, A26, A27, A43, A52, A58, A106, A108, A111 are found to be 13 soap cases weighing 10 grams each. The total weighed was found to be 130 grams. (b) Soap Cases marked as A1, A2, A4, A6, A7, A8, A9, A10, A14, A16, A17, A18, A19, A20, A21, A22, A23, A24, A25, A29, A30, A33, A50, A51, A53, A54, A55, A57, A61, A62, A63, A65, A69, A70, A72, A75, A79, A83, A84, A86, A87, A88, A89, A90, A91, A92, A94, A95, A96, A97, A99, A100, A101, A103, A104, A107, A109, A110, A112 are found to be 59 soap cases

weighing 11 grams each. The total weighed was found to be 649 grams. (c) Soap cases marked as A11, A28, A31, A32, A34, A35, A36, A37, A38, A39, A40, A44, A46, A47, A49, A56, A59, A60, A66, A67, A68, A71, A73, A74, A76, A77, A78, A80, A81, A82, A85, A93, A98, A102, A105 are found to be 35 soap cases weighing 12 grams each. The total weighed was found to be 420 grams. (d) Soap cases marked as A41, A42, A64 are found to be 3 soap case weighing 13 grams each. The total weighed was found to be 39 grams. (e) Soap case marked as A48 was found to be 14 grams and (f) Soap case marked as A45 was found to be 15 grams. The total weighed of 112 Soap cases marked as A1 to A112 was found to be 1267 grams (1.267 KG). The recovered items was packed and sealed inside a white cloth using facsimile seal wherein witnesses and accused appended their signature thereon in the presence of Executive Magistrate.

- (1) Reliable inputs were being received over the last few weeks regarding the transportation of drugs from Myanmar to Aizawl via CCPur in non-commercial vehs. Maj Yadu Krishnan PS and Maj Mohit Podia ex 37 Assam Rifles established an intelligence grid to track the smuggling links. Rigorous and dynamic MVCPs were established in Suangdo-CCPur axis on staggered timings and by tactically exploiting ground resources.
- (2) At around 2100hrs on 06 May 2025, the check post established by 37 AR under Maj Mohit Podia and Maj Yadu Krishnan PS apprehended a brown Renault Duster bearing registration no AS 01 DB 4512, driven by Mr Alex Laljahao Lupheng (29) r/o D. Phailien Village, CCPur and Mr. Lunkhohau Singson (28) r/o Buolmuol Village, CCPur. Initial search of the vehicle revealed a rice bag in which 24 soap cases filled with suspected Heroin No 4, weighing approx 288gms worth appprox Rs. 2.73 crores was concealed. For further investigation and checking, the apprehended individuals and seized contraband were brought to Assam Rifle Battalion Headquarters at Khuga at 2330hrs.
- (3) On reaching Khuga, the vehicle was searched thoroughly for any secret coompartments or modifications. It was found out that a secret chamber was built beneath the boot of the vehicle and concealed with the spare tyre. Inside the secret chamber was approx 01 lakh WIY tablets worth approx Rs 9.26 crores. Detls of the seizure are as follows:
