- 36 Assam Rifles had been tracking the movement & activities of the apprehended individuals namely :-
(a) Mr Thongkhohou Touthang (Age 34), S/o Thopao Touthang, R/o Tonglal Veng, Churachandpur.
- This is to formally inform your office regarding the apprehension of an active cadre of the prescribed outfit Chin Kuki National Defence Force a non SoO gp based in Moreh & Myanmar, namely Mr. Thongkhohou Touthang, aged 34 years, resident of Tonglal Veng, Churachandpur.

- Based on credible intelligence received from source, the individual was reported to be involved in the recruitment of youth for armed insurgency for CKNDF group and cross-border smuggling in Myanmar. It is also learnt that this individual is also involved in recruiting Mr Lunpikai age 14 years R/o Gelbung vell near T Khonkhai.
- Acting upon this input, a well-planned operation was launched at 0300 hrs on 15 May 2025 under N/Sub Tara Singh Sunar. The column apprehended the said individual at approximately 0430 hrs on 15 May 25 at Tuibong without any resistance or civilian disturbance. The operation was executed with utmost precision, maintaining operational security and ensuring zero collateral damage.
- Post-apprehension, Mr. Thongkhohou Touthang was brought to HQ Veng for preliminary interrogation. Initial questioning has indicated possible involvement in cross-border arms and cadre movement.
- In light of the above, it is requested that an FIR be lodged against Mr. Thongkhohou Touthang under relevant sections as applicable.
- Ground of Apprehension – Involved in recruitment of youth for joining CKNDF from CCpur and sending them to Myanmar for training and also involved in demanding extortion from the public on the name of CKNDF.
