FIRST INFORMATION REPORT

1. 37 Assam Rifles has been tirelessly working to destroy the drug network around Churachandpur through various operations in a very short span of time. Based on intelligence gathered from operation Khuga dated 03 May 2025, Operation Gouchinkhup Veng dt 05 May 2025, operation Maukot dt 06 May, 2025, & operation New Lamka dt 10 May 2025, a deliberate plan was devised by 37 Assam Rifles to nab all key drug traffickers in the area. Contact numbers acquired from apprehended individuals of previous operations were put into constant surveillance with the assistance of 11 WEU.

2. In continuance with this, a specific input was received regarding a drug dealer named Doukholet Hanghal working out of Mongkot Khopi Village near Koite, Churachandpur on 22 May 2025 at around 1600 hrs. Input specified that a sizeable amount of drug was stashed in his house. Column str 02-00-15 ex 37 AR led by Maj Mohit Podia and Maj Yadu Krishnan PS used ground resources, devised a plan to nab the drug dealer. They meticulously tracked the perpetrator with the assistance of 11 WEU and launched an operation at 1900 hrs on 22 May 2025. After cordoning the house of the accused, the house of the accused searched by the team including Riflewomen.

3. On searching the house, it was found that 870 gms brown Sugar worth approx Rs 1.74 crores (Rs 8.5 Crores approx in international market) was hidden in a trunk box. 20 x soap cases of suspected No 4 Heroin weighing approx 260 gms worth Rs 52 lakhs (Rs 1.5 crores approx in international market) was found hidden at the shed adjoining the house. Search of the house. On further search of the house, Rs 29.5 lakhs of Indian currency which was acquired by individual from selling drugs in Churachandpur district. Search culminated by 2100h hrs and Mr Doukholet Hanghal (52) yrs resident of Mongkot Khopi was apprehended. For further investigation, the apprehended individual and seized contraband were brought to Assam Rifles Battalion Headquarter at Khuga at 2130 hrs
