Sir,

I have the honour to report that today i.e. 23rd May, 2025 at about 3:30 PM, I received a reliable information that one unknown woman is selling and running a business of suspected contraband items at one house located at Tanguam Village, Churachandpur. Accordingly, requisition was made to District Magistrate to depute one Executive Magistrate for conducting house search. In the meantime, one team of CCP-PS led by self immediately moved to the said spot and the Executive Magistrate namely Shri. Lianminthang Samte also arrived at the spot. On reaching the said house one woman was found inside the said house. On questioning, she identified herself as Mrs. Chingenvung (46) Years D/o. Ginzachin of Kanan Veng, New Lamka, Churachandpur A/P Tanguam Village. As such, information statement was given in writing to the accused person that, she had the right to choose whether her body be searched before the Gazetted Officer or Executive Magistrate or in presence of any witnesses as envisaged u/s. 50 ND & PS Act as I have strongly suspected her to be in possession of Narcotic Drugs and Psychotropic Substances. In that she gave option statement in writing and she chooses to be searched in front of any witnesses. As such, body searched was conducted by one woman police constable namely Woman Head Constable Neikholhing Chongloi on permission of Executive Magistrate, however nothing was found on her persons. A house search was conducted at the residence of Mrs. Chingenvung as contemplated u/s. 42 ND & PS Act in the presence of Head Constable Neikholhing Chongloi of Women Police Station and Executive Magistrate by observing necessary formalities at 4:30 PM. During the search 25 (twenty Five) Soap cases of suspected Brown Sugar wrapped inside plastic packets were recovered which was kept concealed inside one large nylon bag at her bedroom. The suspected brown sugar was open from the soap cases and weighed by using weighing scale and marked as A1 to A25 on each soap cases. On weighing the suspected Brown Sugar the following weight was found for each of the soap cases. a) Soap case marked as A1 was found to be weighing 10 gram. b) Soap Cases marked as A2, A3, A8, A9, A12, A15, A16, A19, A23, A24, A25 are found to be 11 soap cases weighing 11 grams each. The total weighed was found to be 121 grams. c) Soap cases marked as A5, A7, A10, A11, A13, A14, A17, A18, A20, A21, A22 are found to be 11 soap cases weighing 12 grams each. The total weighed was found to be 132 grams. d) Soap cases marked as A4 and A6 are found to be soap cases weighing 13 grams each. The total weighed was found to be 26 grams. The total weighed of 25 Soap cases marked as A1 to A25 including weight of the plastic packets was found to be 289 grams. The recovered items was packed and sealed inside a white cloth using facsimile seal wherein witnesses and accused appended their signature thereon in the presence of Executive Magistrate.

The recovered items i.e. 1. 25 Soap Cases weighing 289 grams of suspected brown sugar 2. Hard Cash of Rs. 8,00,000 /- in Rs. 500 notes denomination 3. 1 (One) large nylon bag used for concealing the suspected brown sugar and the hard cash and 4. 1(one) Mobile Phone ITEL A669L were seized in the presence of witnesses and Executive Magistrate at 4:50 PM. The accused person namely Mrs. Chingenvung (46) Years D/o. Ginzachin of Kanan Veng, New Lamka, Churachandpur A/P Tangnuam Village was arrested at the spot at 5:10 PM.

The seized items along with the arrested person were handed over to you for further necessary legal action against the accused person.
