Subject:- Complaint Regarding Theft and Vandalism at Company Premises by Unknown Persons.

Respected Sir/Madam,

I, the undersigned, am employed as Assistant Restaurant Manager at Devyani International Limited (hereinafter referred to as a 'Company'), which is engaged in the business of operating a chain of Quick Service Restaurants under the brand name 'KFC'.

I am writing this complaint to formally report an incident involving criminal trespass, theft, and willful damage to company property by unknown individuals during the intervening night of 23.05.2025 and 20.05.2025 at the Company's restaurant situated at Gouchinkhup veng, New Lamka, Damkam Bazar area, PinCode-795128.

Brief Facts of the Incident:

1. On 24.05.2025 at approximately 09:00 AM, upon arriving at the store, I noticed that the lock on the back door of the premises had been forcibly broken and the entrance CCTV camera was damaged. I immediately informed the store manager, Mr. Subash, and the landlord of the building regarding the situation.

2. Upon further inspection of the premises, it was observed that :

- The lock on the back entrance had been broken,
- CCTV units covering critical areas such as the cash counter, supply base, back entrance and Manager's room were severely damaged
- An unsuccessful attempt was made to break into the store's safe
- Substantial damage was caused to the CCTV monitor, the Manager's PC and the server screen
- The following items (having value of approx. Rs. 1,94,982.00/-) were found to be stolen :
 - One server unit
 - 7 CCTV camera
 - 3 LED TFT Monitor
 - SMPS
 - Manager CPU
 - Back Door Lock broken
 - One DVR box(16 Channel)
 - Several beverage cans

It appears that unknown miscreants unlawfully entered the premises, committed theft of the property and caused considerable damage to company property with an intent to cause wrongful loss.

In view of the above facts & circumstances, we request you to immediately investigate the matter and register the F.I.R and take appropriate action against the unknown persons involved in the criminal trespass, theft and willful damage to company property.
