Today i.e. 23/02/2025 at 11.30 am received a reliable information that on the same day at around 11.20 am, one Alto car dark-red in colour bearing registration number MN05J-0891 playing from Kakching side toward Wangjing side driven by one unknown driver, dashed on the front side of one Pulsar NS 160 blue and black in colour bearing registration No. MN01AH-0320, playing from same direction ridden by unknown rider near the Gopit Brick Firm along NH No. 102, due to rash and negligent driving on the part of the unknown driver of Alto car. As a result of which the unknown rider of Pulsar NS 160 sustained serious injuries on his person and evacuated to District Hospital Thoubal for medical treatment. The involved vehicles i.e. Pulsar NS 160 was badly damaged however Alto car was partly damaged.

Hence a regular suo-motu case under FIR No. 11(02)2025 KJM PS U/S 281/125(b) /324(4) BNS 2023 has been registered for investigation.
