I have the honour to report that today i.e. 22/02/2024 at about 1:30 p.m. a team of Commando Unit Thoubal led by Shri N. Sadananda Singh, DySP(CDO)/Thoubal assisted by Shri Th. Dinesh Singh, DySP(Ops)/Thoubal and Inspector K. Nitarnan Singh, Officer-in-Charge, Commando Unit Thoubal, Jem. Md. Amin Khan and HC Kh. Rakib under the supervision of Dr. S. Ibomcha Singh, Superintendent of Police, Thoubal District conducted a drive against stolen vehicles at Lilong Alia Lamkhai. Late Abdul Salam of Lilong Awang Leikai respectively were detained for verification. Further, (1) one Honda Activa blue in colour bearing chassis number MF41F50FG8124640 and engine number JF50E83124512, (2) one KTM bike with orange and white in colour bearing chassis number MD2JPEFYOHCO43747 and engine number 7-937 '11481' and (3) one GT Royal Enfield bike bearing chassis number ME3P7E6FGR1001735 and engine number P7A6FGR1250751 suspected to be stolen vehicles were found parking at Lilong Alia Lamkhai area without riders. All the detained two wheelers were seemed to be stolen ones as the riders/owners could not produce any relevant document of the vehicles.




