Sir,

I have the honour to report that today i.e. 07/03/2025 as the dateline of the Hon'ble Governor of Manipur, (No. 10/3/90-DIPR(Vol.II) dated 20/02/2025) along with the appeal made by Superintendent of Police, Thoubal District and his team to the general public of Thoubal District to surrender illegally possessed arms and ammunition etc., has come to an end, District Police, Thoubal along with a team of C/01 Bn. BSF under Adhoc XVI M & C Frontier Stationed at Khongjom Police Station PS and a column of 46 AR Phundrei led by Maj. Anupam, Shri N. Sadananda Singh, MPS, DySP (CDO)/TBL, Shri Y. Sunanta Singh, MPS, DySP(HQ)/TBL, Ms. Diksha Langthasa, IPS (P), independent in-Charge Khongjom Police Station, Inspt. K. Nitaranjan Singh OC/CDO-TBL and 10 teams of CDO/TBL under the supervision of led Shri. Shivanand Surve, IPS, Superintendent of Police, Thoubal launched a massive operation at adjoining area of Langathel Hangoipat by using metal detectors. On searching and found the undernoted articles i.e. (1.) 1 (one) No. 12 Bore Single Barrel (2.) 1 (one) No. of 9 mm Pistol with magazine (3.) 2 (two) Nos. of INSAS Rifle magazine (4.) 2 (two) Nos. of 9 mm live rounds (5.) 6 (six) Nos. of AK live rounds (6.) 4 (four) Nos. of INSAS live rounds (7.) 3 (three) Nos. of 12 bore cartridge (8.) 9 (nine) Nos. of Detonators (9.) 1 (one) No. of WT wireless set (10.) 1 (one) No. of WT wireless set charger (11.) 2 (two) Nos. of BP helmet (12.) 4 (four) Nos. BP vest (13.) 1 (one) No. of BP plate (14.) 2 (two) pair of military shoes and (5) 10 (ten) Nos. of mattress were found from top hill of Langathel Hangoipat at 04:27 p.m. of the same day. Hence the above noted articles were seized at 04:40 p.m. by observing formalities. The massive searched operation was conducted from 04:00 p.m. to 05:00 p.m. on the same day.

So it is therefore, handed over the seized articles to you for your kind consideration and further necessary action.
