

Today i.e. 10th May, 2025 at @ 06.30 PM, found a viral provoking and disturbing video in social media where one popular singer of Manipur "Priyo @ Tapta Macha" gives a statement during a concert. The statement is reproduced as follows, "Manipur gi Saktm kaiba Yaroi" "Kuki Tumna hatkani".

His statement translates as follows "Territorial integrity of Manipur cannot be changed" and "All Kukis must be annihilated".

He was leading and spreading the hate statements motivating and inciting the public where the audience followed his leading hate statements. As such the momentum of feelings of enmity were strongly developed at the public platform.

The viral video provokes the general public which creates fear and alarm to the general public, or to any section of public, whereby any person may be induced to commit any offence against the public tranquillity and incites any class of community promoting enmity, hatred or ill-will between classes on the ground of religion caste or community.

Hence, a suo-mottu case under FIR No. 156(05)2025 IPS u/s 196(1)(a)(b)/351(3)/353(1)(b)(c)(2)/61(2) BNS has been registered against popular singer of Manipur "Priyo @ Tapta Macha" for investigation.
