Sir,

I have the honour to state that today i.e. 14/05/2025 at about 03:55 am, a reliable information was received regarding the presence of some active cadres of UNLF(P) organization (a faction of UNLF organization) in and around Mongjam area of Imphal East District to commit prejudicial activities like extortion of money from the general public and shops etc. Based on the information, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri P. Achouba Meitei, Dy. SP(CDO)IW and under the supervision of Shri Gaurav Dogra, IPS, i/c Addl SP(Ops)/IW and under the overall supervision of Shri Ksh Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted search operation at Mongjam Mamang Leikai area. During that one suspected person was found from a house located at Mongjam Mamang Leikai, Imphal East District who later identified himself as Waikhom Rajesh Singh (32 yrs.) S/o W. Chandramani Singh of Mongjam Mamang Leikai, Imphal East District (who also disclosed himself as the resident of the said house). Due to the requirement of proper verification, he was instructed to appear at CDO-IW office today i.e., 14/05/2025. Accordingly, he along with his family members appeared at CDO-IW office complex, Minuthong today i.e., 14/05/2025 at around 12:10 pm for proper verification. After thorough verification, he disclosed that he is an active member of UNLF(P) organization (a faction of UNLF organization) and he joined the said organisation in October, 2024 through one s/s Commander of UNLF(P) organization namely Thoudam Khingba Meitei @ Chingkhru (Ph. No. 8794750415) S/o. (L) Th. Sunil Meitei from Thambalkhong, Imphal East District. He also disclosed that the above mentioned s/s Commander Thoudam Khingba Meitei @ Chingkhru is his brother-in-law. Further, he disclosed that he is presently working under the command of the above mentioned s/s Commander Thoudam Khingba Meitei @ Chingkhru of UNLF(P) organization and under the instruction of his commander, he served monetary demands/threats and collected money from Cargo Agencies located in valley area and he handed over the extorted money to his commander as their party fund.

Hence, he was arrested from the spot i.e., CDO-IW office complex, Minuthong at 04:02 pm by observing necessary formalities.

From his possession, (i) one Redmi 8 mobile handset along with one Jio SIM card bearing mobile no. 7005310950 (as disclosed by him) and (ii) one Aadhaar card bearing no. 9558 9571 7041 were seized at the spot at 04:11 pm by observing due formalities.

Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him.
