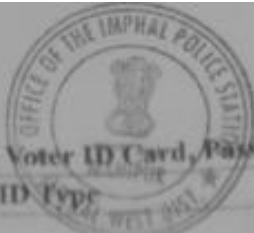

As per endorsed, I have made a discreet inquiry in c/w GD Entry No.11/IPS/2025 dtd. 26.04.2025. During the course of inquiry, the complainant namely Patrick Sh. Slo. Sh. Rojendro Sharma of Uripok Khwai Brahmapur, Imphal, proprietor of Shijagurumayum Enterprise and owner of Khwai Imphal Car and Bike Rental, Uripok have reported to OC/PS stating that on 5<sup>th</sup> Oct, 2024, he rented out one of his vehicle a Honda City, Sedan bearing Registration No. MNO1S 5786 to one individual under a rental agreement for a fixed duration. However, In the meantime, he discovered that the above said individual (Seilash) had fraudulently mortgaged the above said Honda City vehicle to another person. Several times, he had requested to Seilash Soubam to returned the said vehicle but till date he failed to returned the vehicle. On further course of investigation, visited the house of the individual Seilash Soubam of Khurai Ningthoubung Leikai, P.O-Lamlong & P.S-Porompat, Imphal East, Manipur but could not found.
