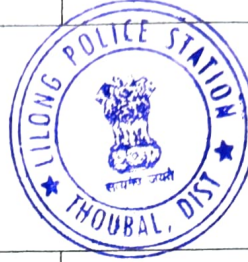

I have the honour to report that today i.e. 21/03/2025 at about 6:00 a.m. a team of Commando Unit Thoubal led by Shri Th. Dinesh Singh, Dy. SP(Ops)/Thoubal assisted by Inspector K. Nitaranjan Singh, Officer-in-Charge, Commando Unit Thoubal under the supervision of Shri N. Suraj Singh, Addl. SP(L/O), Thoubal and under the overall supervision of Shri Shivanand Surve, IPS, Superintendent of Police, Thoubal District were on patrolling at **Waithou Ushoipokpi along NH-102**. On reaching near Ushoipokpi bridge along NH 102 at around 7:00 am, some unknown persons were found standing with two MARUTI SWIFT ZXI white in colour bearing registration number ML04D 1580 & MARUTI SWIFT VXI Grey in colour bearing registration number WB02AF 6824. On their suspicious nature, we immediately got down from our Gypsy and asked the unknown persons to raise their hands but they started to run away from the spot. Our party chased, however they had managed to escape from the spot. While checking the 2(two) car i.e. (1) MARUTI SWIFT ZXI white in colour bearing registration number ML04D 1580, chassis number MBHCZC63SL J626703, engine number K12MP1251058 and (2) MARUTI SWIFT VXI Grey in colour bearing registration number WB02AF 6824, chassis number MA3EHKD1S00694098 and engine number K12MN1427377, it is suspected that the vehicles seemed to be stolen thereby, seized the two MARUTI SWIFT ZXI white in colour bearing registration number ML04D 1580 & MARUTI SWIFT VXI Grey in colour bearing registration number WB02AF 6824 as abandoned from the spot i.e. near Ushoipokpi bridge along NH 102 at 7:10 a.m of 21/03/2025 by observing the legal formalities.
