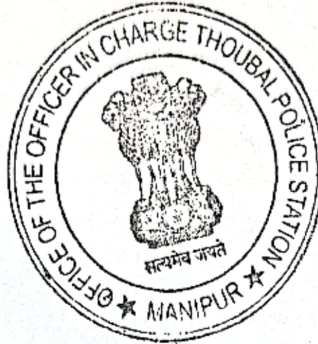

With due respect, I have the honour to report that today i.e 20/02/2025 at about 2.30 pm, my Scooter Honda Activa 6G DLX (Decfent blue metallic in colour) bearing regn. No. MN04G2147, Chassis No. ME4JF914BMD176037 & Engine No. JF91ED1175711, which was registered in the name of one Shaikhom Somorjit Meitei S/o Shaikhom Angangchaoba Meitei of Heirok Part-II Bazar, Thoubal, Manipur was found stolen by unknown person while parked at the gate of one Toijam Baleshwor Singh S/o (L) T. Tomba Singh of Athokpam Awang .Leikai near IFCD Office, Thoubal Athokpam under proper locked and was unable to locate after all the efforts put to trace out the same till date. The value of the said lost/stolen vehicle is worth about Rs. 60,000/- only. The relevant document of the said lost vehicle was also inside the Tool Box (storage compartment) during the incident.
