I have the honour to report that I along with other police personnel of District Police Thoubal being detailed for exam duty in c/w HSLC Examination, 2024 at Evergreen Flower School, Thoubal Ningombam. That, today i.e. 21/02/2025 at around 12:05 pm, when I along with other police personnel who were deployed in c/w Class X BOSEM Examination at Evergreen Flower School, Thoubal Ningombam were controlling traffic movement just after the exam was over. Suddenly, one Chevrolet Beat car B/Regn. No. MN01AK3548 grey in colour confronted our police team. A person who was later on identified as Thangjam Subachandra Singh (30) yrs S/o Th. Shyamkumar Singh of Chanam Sandrok Makha Leikai, Imphal East who is a teacher of KM Blooming Higher Secondary School, Khangabok and one of his associates further called upon some students of the same school i.e. KM Blooming Higher Secondary School, Khangabok who came for appearing class X examination and had assaulted me using criminal force deterring from discharge of my official duty. Further they vandalized the school wall, pelted stone inside the school campus and causes serious injuries to school staffs.

It is, therefore, requested to kindly take up necessary legal action against them.
