Today i.e. 22/02/2025 at 2.30 pm, received an information that on the same day at around 2.23 pm, one Scooter Honda Activa bearing regn. No. MN01AQ-5576 ridden by unknown rider which was coming from Thoubal and proceeding towards Khongjom met an accident with one Bike R-15 bearing regn. No. MN03A2192 ridden by unknown rider which was coming from same direction along NH102 near Fashion House, Wangjing Bazar due to rash & negligent riding on the part of both the unknown riders. As a result of which both the riders were sustained injury on their persons and evacuated to District Hospital Thoubal for medical treatment. Both the vehicles were partly damaged.
