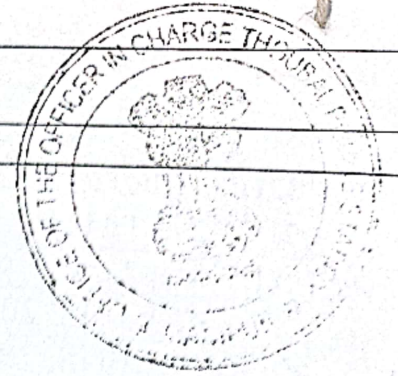

Sir,


I have the honour to report that today i.e. 02-03-2025 at around 10:00 am, during I was at my house, heard some sounds of gunfire nearby. In the meantime, my daughter-in-law namely Mrs Sarida (35) yrs W/o Md. Ajmal Shah received bullet injury on her body while she was plucking vegetables that was grown at the riverbank near my house. It came to know that the fired incident was occurred in between two groups. Later, the culprit was identified as Md. Tamijur Rahaman @ Tami (37) yrs S/o Md. Siraj Ahamad of Sangaiyumpham Pulleipokpi and he intentionally shot and attempted to kill my daughter-in-law by using suspected to be licence firearm.

It is, therefore, requested to kindly take up necessary legal action against the above noted person.
