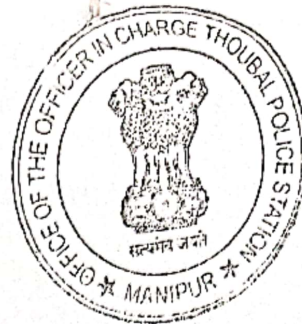

I have the honour to report that today i.e. 02-03-2025 at around 9:45 am, while I was trying to intervend the quarreled in between my son namely Md. Shuaib Ali Khan (38) yrs and Md. Sallao Rahaman @ Sana (35) yrs S/o Md. Siraj Ahamad, Md. Atau Rahaman (32) yrs S/o -do- of of Sangaiyumpham Pulleipokpi with their parties at near my entrance gate. In that, suddenly assaulted to me by the said Md. Sallao Rahaman @ Sana by using stone and also hit on backside by one Md. Tajuddin (30) yrs S/o Late Md. Hessamuddin of Sangaiyumpham Pulleipokpi by using wooden logs. As a result, I received injury on my head and evacuated to hospital for giving medical treatment by my son Shuaib Ali Khan along with some family members.
