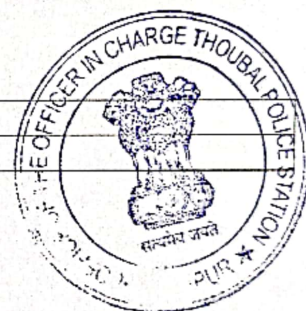

Subject :- Report.

Sir,

With due respect, I have to report that on 02/03/2025 when my son namely Md. Shuaib Ali Khan came in a Swift car bearing Regd.No. MN01G9111 from Imphal after taking ultra sound of his daughter and when he reached at Sangaiyumpham Idigah Road at about 10 a.m. of the said day one Alto Car was also coming from behind on the same direction which was driven by Md. Atao Rahaman aged about 28 years son of Siraj Ahamed of Sangaiyumpham Pulleipokpi Makha Leikai and his elder brother Md. Salao Rahaman @ Sana aged about 35 years was occupant in the said Alto car then the said driver given horn for giving side in a non-stop manner. However my said son could not give for a few minutes due to road conditions and just after about 3 minutes. My said son had given side but the said driver of alto car did not go ahead instead of it he followed towards my said son's vehicle and attempted to dash to my son's vehicle from behind and they used many slang languages and also abused to my said son. Moreover Md. Salao Rahaman @ Sana called on phone some their relative persons and informed to bring some guns and try to stop my son's vehicle at Nungphou. Then my son driven his said vehicle fastly towards our residence. The said alto car also coming in high speed as followed of my said son's vehicle upto our gate. Then they get down from the said vehicle and assaulted by using stones and hitted to my husband's forehead and also kicked to our relative persons. Moreover their some relative persons were also coming by bringing some guns and fired towards our men. As a result of which my husband viz. Md. Azad Khan, one son and some 4/5 our relative persons were seriously injured on their persons and they are causing hospitalised at RIMS and Raj Medicity Hospital which is undergoing medical treatment now. A colour photo showing some accused persons holding guns and sticks of their hand is enclosed herewith.



The following accused persons had committed the said crimes, they are :-

1. Md. Atao Rahaman aged about 28 years son of Siraj Ahamed.
2. Md. Siraj Ahamed aged about 40 years son of (L) Haji Tomba.
3. Md. Tamijur Rahaman aged about 40 years son of Siraj Ahamed.
4. Md. Mujibur @ Achou aged about 48 years son of Najir Ahamed.
5. Md. Ibocha aged about 45 years son of Najir Ahamed.
6. Md. Sarif Khan @ Saruk Khan aged about 21 years son of Md. Ibocha
7. Md. Abish Khan aged about 32 years son of Najir Ahamed.
8. Md. Aba Khan aged about 58 years son of Haji Hatim Ali.
9. Md. Manao aged about 55 years son of Haji Hatim Ali.
10. Md. Arab Khan about 31 years son of Md Manou
11. Md. Abdur Rahaman about 35 years son of Mv. Yusub Ali.
12. Md. Tajuddin about 22 years son of (L) Md. Hesamuddin.
13. Md. Nawaj Sarif about 22 years son of Md. Hibjur Rahaman.

All are residence of Sangaiyumpham Pulleipokpi Makha Leikai, PO-Wangjing, P.S. & District Thoubal, Manipur.

It is therefore report you to kindly take up a suitable case against the above accused persons and punish them according to law. I could not report in time due to heavy engagement to the treatment of our injured persons and also I have no legal knowledge.
