Subject: Complaint against Nungombam Maniyama Devi (aged about 65 yrs), Nungombam Saratchandra (aged about 48 yrs) s/o N. Maniyama Devi, Nungombam Nelson Singh (aged about 21 yrs) s/o N. Saratchandra Singh, Nungombam Mangal Singh (13/14 yrs) s/o N. Saratchandra Singh, residents of Thoubal Nungombam Mayai Leikai and one of their close aides.

Sir,

I, undersigned, hereby lodge a complaint against the above named persons to the effects as given herein under, that

1. Nungombam Saratchandra Singh s/o N. Maniyama Devi created nuisance by way of shouting in filthy language at the gate of my residence almost every day at night.

2. On 15th March, 2025 at around 9.10 pm when I along with my wife namely Reena Devi Nungombam (aged about 50 yrs) approached his mother namely Nungombam Maniyama Devi with the aim of informing her about her son's nature, she pushed me down and due to which, I fell down from the top of her verandah staircase and thereafter, Nungombam Nelson Singh along with one of his friends physically assaulted me thereby causing injuries to my right eyelid, left elbow and ankle of my right leg. As of now, I cannot move properly without any physical support.

3. Furthermore, Nungombam Nelson Singh with his friend (name unknown) and his younger brother namely Nungombam Mangal Singh assaulted physically my daughters namely Sarakha Nongthombam (aged about 27 yrs) and Nongthombam Subarata (aged about 25 yrs), pressed their necks and also pulled their hairs, and even spat spat over their face.

Attached to this letter are supporting documents such as photographs, medical reports etc.

As such, I request you to kindly look into this matter and take necessary legal action at the earliest.
