I have the honour to report that on 20/3/2025 at about 12:30 pm, my scooter Honda Activ 5G (red in colour) bearing regd. no. MN04D9131, chassis no. ME4JF50BGJ7072707 and engine no. JF50E78072743 which is recorded in the trame of my husband Shougrakpam Ratan Singh s/o S. Ibopishak Singh of Thoubal Nongangkhong, Thoubal District, Manipur-795138 worth Rs 80,000 was found missing while it was parked at Thoubal Nongangkhong near Chinga Lairemb Temple with proper lock.
