Subject: Complaint Against Mr. Huidrom Bhujjal Singh for Misappropriation of
Office Collection and Missing Office Computer (CPU)

Dear Sir,

We hope this letter finds you well. We are writing on behalf of Aegis Precision Pvt. Ltd. to file a formal complaint against Mr. Huidrom Bhujjal Singh, S/o H. Tombi Singh, Bashikhong Kongba Irong, Imphal East (contact: 9233103428 / 9863651023 / 8837438977), In-charge of the Smartcard Printing and Office Collection for the State of Manipur (excluding Imphal East), who has been employed with our company for the printing and implementation of the Smartcard project in Manipur.

The following offenses have come to our attention, and we request your immediate action:

A. Misappropriation of Office Collection

1. During the financial audit for the year, it was discovered that Mr. Huidrom Bhujjal Singh, aged 31 years, has misappropriated a sum of approximately Rs. 14,32,200 (Fourteen Lakhs Thirty-Two Thousand Only)
2. Upon repeated reminders from colleagues and co-staff, Mr. Bhujjal Singh handed over Rs. 4,73,000 (Four Lakhs Seventy-Three Thousand Only) on March 28, 2025, through his brother. However, he has failed to return the remaining amount of Rs. 9,59,000 (Nine Lakhs Fifty-Nine Thousand Only). Despite numerous follow-ups, he has not reported to the office, citing health issues, although reliable sources confirm he was in working condition.

The misappropriated amount includes collections from December 2024 to March 2025 across various districts (Thoubal, Bishnupur, Chandel, Tamenglong, Kangpokpi, Ukhrul, Senapati, and Imphal West). Some amounts were collected in cash, while others were sent via GPay/UPI to his contact number (9233103428). The details of amounts sent via GPay are as follows:

- o Ukhrul: Rs. 2,27,400
- o Senapati: Rs. 1,35,400
- o CCPUR: Rs. 63,200

Total Mismatch: Rs. 14,32,000 (approx.) **Recovered Amount:** Rs. 4,73,000 **Remaining Amount:** Rs. 9,59,000 (approx.)

We believe Mr. Huidrom Bhujjal Singh is directly responsible for this financial misappropriation, resulting in a significant loss for our organization. We kindly request your intervention to address the situation.

B. Missing Office Computer (CPU)

Additionally, on the morning of April 2, 2025, at around 09:53 AM, one of our staff members, Naorem Pushparani, discovered that three Lenovo CPUs (one black and two grey) were missing from the office smartcard room, located at the Directorate of Transport, Babupara, Imphal West.

We request an investigation into the missing computer equipment along with the misappropriated funds.

Requested Action:

We kindly request that you:

1. Register a formal case against Mr. Bhujjal Singh under the relevant sections of the law for the misappropriation of office funds.
2. Conduct a thorough investigation into both the financial misappropriation and the missing office equipment.
3. Take necessary action to recover the misappropriated funds and the missing computer hardware.

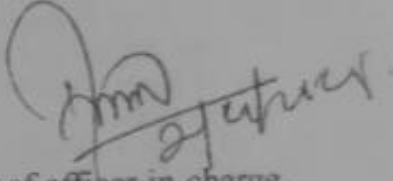

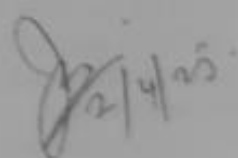
