Subject: Report.

Sir,

I have the honour to state that today i.e 20/05/2025 @ 7:30 am, a random frisking and checking was conducted at Taphou Nepali Village along Senapati – Thonglang Road, Senapati District, Manipur by a joint team of Senapati Police Special Operation Team and B/109, CRPF, Quick Action Team (QAT). While conducting frisking and checking, one vehicle Scooty (NTORQ 125) Black and Red in colour bearing Reg. No.AS09K 2489 was seen coming from Thonglang side towards Senapati. The said vehicle was stopped for frisking and checking. On enquiry, the driver of the vehicle is identified as Roman Rai (21) yrs s/o Dhamlal Rai, Gorkha Harup, Irang Part-II, Tujang Waichong, P.O & P.S – Kangpokpi, Senapati. On checking the vehicle, suspected opium was found concealed below the seat of the vehicle. As such DC/SPT was intimated by my senior officer and a request was made to depute one magistrate. Accordingly, ADM/SPT Shri. Rang David (42) yrs (Executive Magistrate) was deputed for doing the necessary procedures.

On arrival of the Executive Magistrate and in his presence and in the presence of the driver namely Roman Rai (21) yrs s/o Dhamlal Rai, Gorkha Harup, Irang Part-II, Tujang Waichong, P.O & P.S – Kangpokpi, Senapati, the vehicle was thoroughly checked. On checking two packages of suspected opium were found concealed below the seat of the vehicle.

The 2(two) packages suspected to be opium were weighed by using weighing machine in the presence of the Executive Magistrate and witnesses and weighted 2.003 kg (with plastic cover). The approximate value is Rs. 1,40,210/ (one lakh forty thousand two hundred and ten). The 2(two) packages of suspected opium were seized in the presence of the Executive Magistrate and witnesses by preparing a formal seizure. The detained person was formally arrested by observing formalities.

Particulars of the seized items:

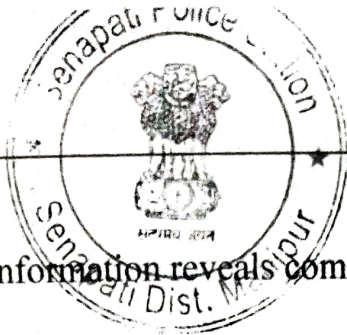
1. 2(two) packages of suspected opium, weighing 2.003 kg with plastic cover.
