Subject :- Report.

I have the honour to report that today i.e. 03/05/2025 at about 07:25 p.m. received a reliable information from SAFE/TBI (special action force for extortion) that some active cadres of KCP(Apunba), a banned unlawful organisation were loitering in and around Thoubal and Yairipok area for prejudicial activities like extortion, kidnapping etc. Acting on the information, after giving necessary information to SP control Imphal East, organised a joint team of Commando Unit Thoubal led by Inspt. K. Nitaranjan Singh, MPS, Addl. Charge, Commando Unit, Thoubal under the supervision of Shri Hijam Devendra Singh, IPS, Superintendent of Police (Ops) Thoubal and under the overall supervision of Shivanand Surve, IPS, Superintendent of Police Thoubal District and a column of 5/9 Gorkha Rifle immediately rushed to Yairipok Laimanai area at around 07:50 p.m. and conducted random frisking and checking of suspected persons. In that one unknown was seen coming from Yairipok Top Chingtha side towards Yairipok Laimanai side in a very suspicious manner. On suspicion, the unknown person was detained for verification.

On preliminary verification, the unknown person identified himself as Lairenlakpam Dineshchandra Singh 30 yrs. s/o L. Ibohalmi Singh of Thoubal Wangkhem Mamang Leikai, Thoubal District, an active cadres of KCP(Apunba) City Meitei.

On further verification he disclosed that he and his associates were involved in prejudicial activities like extortion, kidnapping, snatching mobile phones and hijacking vehicles from the general public in Thoubal and Yairipok area and monetary demand at Thoubal District Hospital, Khangabok by using arms. Further he disclosed that he was arrested on 03/06/2024 by CDO/TBI, after released he re-join to KCP(Apunba) and working under the command of one Paikhomba, a Father of Nambol of their Organisation.

On his body search found- (1) 1(one) 9 mm pistol marked as B-1015 along with magazine and 5 (five) live rounds, (2) 1 (one) Redmi mobile phone with one Airtel SIM card bearing mobile No. 8132061874, (3) 1 (one) wallet black in colour, (4) a sum of Rs. 200/- (of different denomination) (5) 1 (one) PAN card bearing No. JFTPS8625J registered in the name of Lairenlakpam Dineshchandra Singh, (6) 1 (one) Driving licence bearing No. MN04 20190001986 registered in the name of Lairenlakpam Dineshchandra Singh, (7) 1 (one) Aadhaar card bearing No. 8333 0000 7113 registered in the name of Lairenlakpam Dineshchandra Singh, (8) 1 (one) ATM card of Canara Bank and (9) 1 (one) voter ID card bearing No. LFW0355115 registered in the name of Lairenlakpam Dineshchandra Singh were detected from his possession.

Hence, he was arrested at 08:02 p.m. of 03/05/2025 from the Yairipok Laimanai near Sacred Heart School by observing formalities and seized the above mentioned articles i.e. (1) 1(one) 9 mm pistol marked as B-1015 along with magazine and 5 (five) live rounds, (2) 1 (one) Redmi mobile phone with, (3) 1 (one) wallet black in colour, (4) a sum of Rs. 200/- (of different denomination) (5) 1 (one) PAN card bearing No. JFTPS8625J, (6) 1 (one) Driving licence bearing No. MN04 20190001986 and (7) 1 (one) Aadhaar card bearing No. 8333 0000 7113, (8) 1 (one) ATM card of Canara Bank and (9) 1 (one) voter ID card bearing No. LFW0355115 were seized at 08:03 p.m. of the same day from his possession by observing formalities.

It may be mentioned that all the necessary formalities under BNSS i.e. preparation of seizure memo and arrest memo by taking videography during seizure could not be done at the spot as information was received from intelligence sources that some members of the above said unlawful organisation may attack or some organised public mob may be initiated to forcefully free the arrested accused person.

The arrested person mentioned above along with the seized items are handed over to you for taking further necessary legal action against him.




