Imtiyas Khan of Sangaiyumpham Part-I Mairenkun reported to OC-TBL/PS stating that an individual namely Md. Jalauddin Khan aged about 36 yrs S/o. Apik of Sangaiyumpham Part II near Idigah Forest Leikai came to her house and asked her that her husband namely Md. Imtiyaj Khan (33)yrs. S/o Md. Mihhajuddin of Sangaiyumpham Part I Mairenkun to go for Dimapur in c/w a matter. As he accepted the proposal, they together departed for Dimapur from their house on 20/04/2025 at about 11:00 a.m. However, on the same day at about 3:30 pm, she was informed by Md. Jalauddin Khan that her husband has been held captive by some unknown persons somewhere at Lilong and she could not communicate her husband since his mobile phone bearing mobile no. 8837349455 remained switch off. It refers to GD Entry No. 13/TBL-PS/2025 dated 21/04/2025. In this regard, an enquiry has been conducted where she was examined thoroughly and recorded her statement. Further, the Inquiry Officer along with a Police team had visited at the house of the above said individual namely Md. Jalauddin Khan, however he was not found at his house. On 21/04/2025 at around 07:25 pm, the individuals namely Md. Imtiyaj Khan (27) yrs S/o. Md. Minhajuddin of Sangaiyumpham Mairenkun Makha Leikai along with four others namely, 1) Md. Zamir, 28 yrs s/o. (L) Md. Murumudin of Sangaiyumpham Mairenkun 2) Md. Amir Khan (26) yrs. S/o. (L) Md. Alauddin of Sangaiyumpham Mairenkun Mayai Leikai and 3) Md. Abdul Aziz (22) yrs. S/o. Md Abir Khan of sangaiyumpham Puleipokpi and 4) Md. Fakir Ahamed @ Tomba, 38 yrs S/o Md. Abdul Salam of Ling Turel</p>			

				Ahanbi Atoukhong were handed over to TBL-PS after being rescued from Ingourok by teams of CDO-TBL. On examination of the 4(four) individuals as well as Imtiyaz, it is learnt that the person noted in sl. No. 4 turns out to be an accused person who was part of the conspiracy in abducting the noted four individuals for ransom by keeping under wrongful confinement and wrongful restrain. On taking statement of the four victims, it came to light that other than the above mentioned, Md. Fakir Ahamed @ Tomba and two other individuals namely Islauddin 44 yrs S/o late unknown of Lilong Tairen Makhong, and Md. Achouba 48 yrs S/o unknown of Lilong Tairen Makhong along with two unknown associates were part of the team who had abducted them for a common cause of illegally demanding ransom. Accordingly the accused person namely Md. Fakir Ahamed @ Tomba, (38 yrs) S/o Md. Abdul Salam of Ling Turel Ahanbi Atoukhong was arrested at 9 pm of 21/4/2025 at Thoubal Ps campus. Hence the case

Acting on the information, a joint team of Ex Column of 4 AR, Thoubal, a team of C/01 BN. BSF and team of Khongjom PS led by Ms. Diksha Langthasa, IPS (P) independent Charge, Officer in Charge, Khongjom PS immediately rushed to Uningkhong area along NH-102 at around 1:10 p.m. and conducted random frisking and checking of suspected persons and vehicles. In that, 1(one) Tata Magic passenger vehicle white in colour was seen coming from Wangjing side towards Khongjom side. Further, Tata Magic was detained for verification. SP(Ops)/Thoubal and under the overall supervision of Shri Shivanand Surve, IPS, SP/Thoubal District and a column 46 AR Phundrei led by Maj. Khelendro Singh of Khongjom Kheba Ching at 01:28 p.m. of 04/04/2025 from the spot by observing formalities. He further disclosed that he joined KCP(People's War Group) in the month of July, 2023 through one Langamba of their organisation and got 45(forty five) days Basic Military training at Karang under instructor Nongthang. After completion of his training he was posted at Karang. He further disclosed that they were involved for the extortion of money from general public of Khongjom and Heirok areas i.e. Brick fields, Sawmill, Bank, Hospital, Schools, Colleges, Oil pump, Shop & Stone Crusher Contractors etc. of Thoubal District area for the organisation (KCP(PWG)). On his body search, which was videography found (i) 1(one) Redmi Note 13 with 1(one) Jio SIM card bearing mobile number 9366096079, (ii) 1(one) Nokia key pad mobile with 1(one) Airtel SIM bearing mobile number 6909623216. Then, they searched his house, which was videographed. During the house search, found 1(one) 9 mm pistol with one magazine and 6(six) nos. of 9mm live rounds kept concealed inside a shoe box which was kept at red colour Godrej and seized from his possession from the spot at 02:10 p.m. of 04/04/2025 by observing</p>

She further disclosed that on 09/04/2025, she received extortion money of Rs. 5 lakhs from one unknown person of PREPAK (Pro) organisation sent by the above mentioned Sana of PREPAK (Pro) organisation and she kept the above amount of extortion money i.e., Rs. 5 Lakhs in her custody and later on, as instructed by the above mentioned Sana of PREPAK (Pro) organisation, out of the above mentioned amount of extortion money i.e., Rs. 5 Lakhs, a sum of Rs. 4 Lakhs was handed over to three unknown persons including two women of PREPAK (Pro) organisation (sent by Sana) and on 10/04/2025, the remaining Rs. 1 lakh was handed over to one unknown person of PREPAK (Pro) organisation (who was also sent by Sana). On reaching at the suspected area i.e. YBC Club adjacent to SDC office, Heirolk Part-III, Thoubal District cordoned the area and entered into the said club. In that 7(seven) nos. of suspected persons were found along with some weapons and dress (camouflage). In the meantime, nearby villagers create an unruly mob and started pelting stones and obstruct to police duty. In that firing live rounds and tear smoke shells in the air to disperse the mob and the suspected individuals along with weapons and dress including the two vehicles were brought to a safe place i.e. at Lilong Police Station. On arrival at Lilong Police Station, the individuals were identified as 1) Waikhom Dingku Meitei aged about 28 yrs s/o W. Budhichandra of Yumnamn Huidrom Khunyai Leikai, P.O. & P.S. - Wangoi, IW, 4) Angom Bobi Meitei @ Wataba, aged about 33 yrs s/o A. Imo Meitei of Nongada Awang Leikai, P.O. & P.S. - Lamlai, IE 5) Ningthoujam Choaba Singh @ Hingchaba, aged about 38 year S/o (L) N. Kulabidhu Singh of Thongju Pishum Lampak, P.S. - Singjamei, IW, 6) Laishangthem Tomba @ Thabal Meitei aged about 25 yrs s/o L. Bemcha Devi @ Demcha, aged about 57 yrs. of Heirok Part-III Kabo Leikai for prejudicial activities like extortion, kidnapping etc. Acting on the information, a joint team of Commando Unit Thoubal led by Inspt. K. Nitaranjan Singh Officer-in-Charge, Commando Unit, Thoubal under the supervision of Shri H. Devendra Singh, MPS, Addl. Superintendent of Police(Ops) Thoubal and under the overall supervision of Shivanand Surve, IPS, Superintendent of Police, Thoubal District and a column of 4 AR COB, Thoubal and 10th Bn. BSF immediately rushed to the house of Abujam Tomba Singh aged about 57 yrs. of Heirok Part-III Kabo Leikai at around 04:20 pm. On seeing the police party some unknown persons were seen running from the house of Abujam Tomba Singh trying to escape from the police party. In that, the police party swiftly over powered and detained one person, but when the team were almost near to them and nab them but some local people approached there and blocked our police party allowing the another 4(four) unknown persons to escaped from us. Further nearby villagers started creating an unruly mob, pelting stones and obstruct to police duty. The unruly mob even attacked to the police party by using sticks. In that, 1(one) Rashak Plus bearing Engine No. WRN4G11381 allotted to OC, CDO Unit, Thoubal 1(one) Maruti Gypsy b/regd. No. MN 01W 3499 allotted to Golf- 80 (Hav. No. 1711691 Md. Kamal Hassan of 7th IRB) respectively were damaged by the unruly mob (.) On preliminary verification, the person identified himself as Naorem Punshiba Meitei @ Baby (20 yrs.) s/o (L) N. Premjijt Meitei of Wangoo Lamkhai, PS- Wangoo & PO- Kakching, an active member of banned outlawed KCP(MFL) organization. On his body searched found 1(one) .32 Pistol marked as "MADE IN INDIA" along with magazine and 3 (three) live rounds from his possession. He disclosed that, he joined KCP(MFL) through one Henthoiba of their organization. He further disclosed that, he involved in prejudicial activities like extortion, kidnapping etc. in Thoubal District. Hence, he was arrested at 04:22 p.m. and seized the above mentioned .32 Pistol marked as "MADE IN INDIA" along with magazine and 3 (three) live rounds at 05:26 p.m. of 30/04/2025 by observing formalities. It may be mentioned that all the necessary formalities under BNSS i.e. preparation of seizure memo and arrest memo by taking videography during seizure could not be done at the spot as information was received from intelligence sources that some members of the above said unlawful organisation may attack or some organised public mob may be initiated to forcefully free the arrested accused person. Hence the case.</p>
