This is to report that on 08/03/2025 at about 2:20 p.m. a joint team of CDO/BPR led by myself and assisted by Hav. Md. Rafik, Hav. Khs Khorongam Chiru, Hav. Ch Bobo Singh, Hav. S. Hemanta Singh, a team of PGCI-PS including woman PC led by Inspector Subhashchandra Konthoujam, OC/PGCI-PS and personnel of 19th Garhwal under the command of Sub. Y. Shaktishen, OC/CDO-BPR under the supervision of Shri Amarjit Singh Lamabam, MPS, Addl. SP(Ops)/BPR and overall guidance of Shri Ksh. Ravikumar Singh, IPS, SP-BPR were conducting regular frisking and checking in front of Ibudhou Thangjing Temple of Phougakchao Awang Leikai along tiddim road, one passenger diesel auto b/reg. no. MN01L/4189 which was coming from Churchandpur towards Kwakta bazaar was stopped for checking. On checking the occupants of the said Diesel auto, one of the passengers identified herself as Farida Begum (37), W/O Md.

Mohibur of Yairipok Tulihal, currently residing at Kwakta Terakhong Ward No. 1 (KMC) was found behaving suspiciously.

She was given the option to undergo a body search in the presence of a Gazetted Officer or an Executive Magistrate to which she opted for the presence of a Gazetted Officer. Accordingly, D. Robinson, DySP-II, who was on convoy duty at Phougakchao Bazar, was informed and arrived at the location. She was then taken to a private area nearby, where W/PC conducted body search and her belongings in presence of civil lady witness. Upon checking her belonging red handbag, two soap cases suspected to have contained heroin powder were found concealed inside. On further body search recovered eight more soap cases hidden in her front stomach area. In total, 10 soap cases were recovered weighing approximately 127 grams of suspected heroin powder, excluding the weight of the containers. For identification, the soap cases were marked as A1-13gms, A2-12gms, A3-14gms, A4-13gms, A5-12gms, A6-13gms, A7-13gms, A8-13gms, A9-11gms, and A10-13gms. On further examination, she disclosed that the soap cases containing heroin powder were brought from one Chochong Kipgen aged about 50 years of New bazar, Churchandpur for further handing over to one lady namely Champa aged about 38 years presently staying Hatta, Imphal East.

Thereafter, the 10 (ten) soap cases along with one Realme mobile phone with JIO sim card bearing mobile no. 8014165488 and one red colour carry bag were seized from the possession of Farida Begum at 02:50pm and later the 10 soap cases were packed and sealed after putting inside a cartoon box in presence of D. Robinson DySP, CDO/BPR and civil witnesses. After completing all due formalities, she was arrested at 03:00pm and the arrested person along with the seized articles were handed over to OC/PGCI-PS for taking up necessary legal action.






