First Information contents: On 18/06/2025 at 1327 hrs, one Mr. **Phungreikui Rephung** (49 yrs) s/o Mr. **Wilson Rephung** of Seikhor Village, Convenor RTI Committee, MGNREGS, Seikhor Village reported to this PS stating that 2 (Two) individuals namely Mr. **Daniel Leisan** (80 yrs) s/o Lt. Mr. **Shangrei Leisan** and Mr. **Stillwell Leisan** (67 Yrs) s/o Lt. Mr. **Shamphang Leisan** of Seikhor Village, Ukhrul District, Manipur, former Chairman and Secretary respectively of MGNREGA Seikhor Village has misappropriated a sum of Rs. 26,78,528 from the fund allocated for material components under the MGNREGA scheme for the financial year 2022 & 2023 of Seikhor Village which prima facie attract the provision of prevention of corruption act, 1988.

Hence, a normal case under **FIR No. 02(06)2025/LM-PS, U/s 316/318 r/w section 3 (5) BNS, 2023 and 13(1)A r/w 13(2) Prevention of corruption Act, 1988** was registered and endorsed to Inspector Krili James CH, OC/Somdal-PS for investigation.
