In inviting a reference to GD Entry No. 18/HRK-PS/2025 dated 25th April, 2025 of the Office of Heirok Police Station I have the honour to state that on endorsing the matter to me by the OC, Heirok Police Station I have conducted a preliminary enquiry on the matter of snatching of arms of one Shri Atom Kirankumar Singh by unknown armed persons.

The brief history about the matter is that one Shri Atom Kirankumar Singh S/O Atom Ibotombi Singh aged about 41 years of Thoubal Haokha Mamang Leikai, P.O. & P.S. Thoubal District reported a complaint to the Superintendent of Police, Thoubal against snatching of his Arms on 18th November, 2024 and the Office of the Superintendent of Police, Thoubal District in its Endst. No. 8/2/2025/SP-TBL/2331 dated 24th April, 2025 directed this Office to take necessary action. Subsequently, this office made a GD Entry No. 18/HRK-PS/2025 dated 25th April, 2025 on the matter. Further the complainant made an application to this Office dated 8th May, 2025 to make a correction to his Arms Details as per an order of the Office of the District Magistrate, Thoubal District dated 02nd May, 2025.

During the preliminary enquiry the complainant Shri Atom Kirankumar Singh S/O Atom Ibotombi Singh aged about 41 years of Thoubal Haokha Mamang Leikai, P.O. & P.S. Thoubal District claimed the following that:

1. He had in possession one NPB Pistol bearing No. 189112969 by RFI-IN-2028/19 purchased on 01/01/2024 from Ningthouja Arms & Ammunition, Thoubal app. Thoubal PS under License No. (MHA)-LN 22428A7A18 [REDACTED] UIN-224281001831242019, Serial No. of License Booklet L/No. 1503-TBL issued by the Deputy Commissioner, Thoubal District.
2. He was doing some stone quarry related business in Heirok-Thamlai area and had been conveying frequently in the Wangjing-Heirok IVR for the business-related purposes.
3. On the early morning of the day of the incident i.e. 18th November, 2024, he was going to the Village Thamlai through the Heirok-Ingangklok IVR to talk about business with one Koshang, Chairman of Thamlai Village, Machi Sub-Division, Tengnoupal District on one Mahindra Bolero bearing Registration No. MN 05A 4958 but after contacting him on phone, as Koshang was out of village for some work, he came back on the same route for home. In this journey, he carried his pistol with 15 (fifteen) nos. of bullets for his personal self-defence and protection.
4. On the way back home in between Ingangklok and Litan on the Heirok-Ingangklok IVR at around 8:00 am some unknown armed miscreants stopped his vehicle and frisked him and in the process snatched his pistol and threatened him not to report to any authority regarding the matter and took his contact details assuring him they will return the gun to him afterwards.
5. And due to the sheer threat put to him by the unknown armed persons and due to fear of backlash and dire-consequences from these unknown armed persons he has not reported to any authority regarding the matter until he filed a complaint to the Superintendent of Police, Thoubal District on 7th of April, 2025.

During this enquiry the undersigned tried to verify the claims made by the complainant and also other records received by this office. In relation to this enquiry, I would like to state the following few lines that:

1. The undersigned verified the claims made by the complainant that he was doing business at Heirok-Thamlai area. To ensure this the undersigned spoke to Makunga Koshang S/O Late Korungin aged about 36 years, Chairman of Thamlai Village, Machi Sub-Division. Tengnoupal District and he verified that he was doing stone quarry related business with the complainant.
2. The undersigned verified the phone records of both the complainant and Mr. Koshang on the day of the incident. The phone records showed that Mr. Koshang called the complainant at around 6:13 am to which the complainant didn't pick up the call and in return the complainant called Mr. Koshang at 6:51 am and spoke to him for 4 minutes and 50 seconds.
3. The undersigned also found other phone records of both the complainant and Mr. Koshang thus verifying the fact that they were in frequent touch to talk about the business.
4. The undersigned also spoke to two other persons Shri Tonjam Romen Singh S/O Late Tonjam Ingo aged about 30 years of Heirok Part II and Shri Thochom Oken Singh of Heirok Part-II whereby they verified the claims of the complainant that he was frequently travelling in the Heirok-Ingangklok IVR in particular and in the Heirok-Thamlai area in general. The second person also verified the fact that the complainant was frequently carrying his License Gun for self-protection in his trips at Heirok area.
5. The undersigned visited the Place of Occurrence but could not ascertain anything substantial to verify the exact place as there were no access to any witnesses as well as any CCTV Cameras in the area.
6. The undersigned also came to the knowledge of one message passed on to all the OsC of Police Stations in Manipur by the OC of Sagolmang Police Station vide MSG No. 4/SMG-PS/2025/124 dated 3rd May, 2025 intimating about any case registered at any police station regarding the loss/snatch of one Arms bearing 0.32 Pistol Bearing Body No. 189112969 marked with "PISTOL 0.32 MK-II 189112969 RFI-IN2018-19 along with one magazine loaded with 5 (five) rounds of 0.32 ammunition as the Sagolmang PS has seized the above mentioned arms in relation to a Case FIR No. 10 (04) 2025 SMG-PS u/s/ 140(3) BNS, 17/20 UAP Act and 25 (1-C) Arms Act added 3 (5) BNS. This message verified the fact that the arms of the complainant was actually in hand of some armed unknown persons.
7. The undersigned also verified the corrected Arms License produced by the complainant before me. The Arms License produced before me as issued by the Office of the District Magistrate Thoubal District dated 02-05-2025 is recorded as:

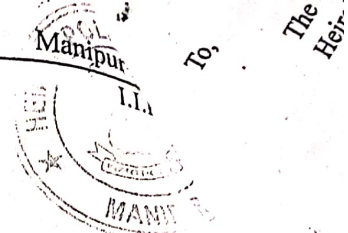

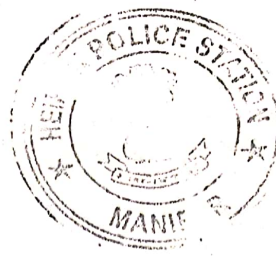
